John L. Taylor of Bingham, for damage to car caused by truck of inland fisheries and game department.	50.00

Chapter 61

RESOLVE, Authorizing the Purchase of Property for the State.

Certain land to be bought. Resolved: That the sum of \$32,500 be, and hereby is, appropriated to be expended by the governor and council in buying the F. & H. Real Estate Corporation property, situated on the west side of State Street in the City of Augusta, being the land and buildings thereon referred to in the deed from Harry H. Pierce, Jr. to F. & H. Real Estate Corporation, recorded in the Kennebec Registry of Deeds in Book 674, Page 386, dated December 27, 1930; and the governor and council are hereby directed and authorized to purchase such property for the use of the state.

Chapter 62

RESOLVE, for the Purchase of One Hundred Copies of "History of Morrill, Maine".

"History of Morrill, Maine"; purchase of. Resolved: That the state purchase 100 copies of the book entitled "History of Morrill, Maine" written by Timothy W. Robinson, at \$5 per copy, said books to be exchanged or distributed at the discretion of the state librarian; and that there be, and hereby is, appropriated for this purpose the sum of \$500.

Chapter 63

RESOLVE, Reimbursing the Town of Trescott for Bounty Paid to Vincent Foley.

Town of Trescott; reimbursed. Resolved: That there be, and hereby is, appropriated, in favor of the town of Trescott, the sum of \$10, to re-

imburse said town for bounty on bear which said town paid to Vincent Foley; said sum to be paid from the dog license fund.

Effective July 9, 1943

Chapter 64

RESOLVE, in Favor of the Town of Newry for Bounty Paid.

Town of Newry; reimbursed. Resolved: That there be, and hereby is, appropriated, in favor of the town of Newry, the sum of \$10 to reimburse said town for bounty on bear paid to Fred W. Wight, of Newry; said sum to be paid from the dog license fund.

Effective July 9, 1943

Chapter 65

RESOLVE, in Favor of Leland Andrews, of Hartford.

Leland Andrews, compensated. Resolved: That there be, and hereby is, appropriated in favor of Leland Andrews, of Hartford, the sum of \$700, as a full and final settlement for all claims against the state for damage to sheep caused by bear; said sum to be paid from the dog license fund.

Chapter 66

RESOLVE, in Favor of William F. Tracy, of Passadumkeag.

William F. Tracy, of Passadumkeag, compensated. Resolved: That there be, and hereby is, appropriated the sum of \$2,643, to be paid to William F. Tracy, of Passadumkeag, as a full and final settlement of all claims against the state for damage to him resulting from the appropriation by the state of Russell Pond Camp, located in Township 4, Range 9, W. E. L. S., Piscataquis county, consisting of 5 cabins and equipment contained in said buildings; said sum to be paid from the general funds of the state.
