#### Chapter 10

AN ACT to Ratify and Make Valid the Incorporation of the Harry G. Decker Post No. 51, The American Legion.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Incorporation of Harry G. Decker Post No. 51, The American Legion. The incorporation of Harry G. Decker Post No. 51, The American Legion in Oakland, county of Kennebec, in 1925, in accordance with the provisions of the statutes of Maine in such case made and provided, under the name and title of Harry G. Decker Post No. 51, The American Legion, is hereby ratified, affirmed and made valid, and all acts and doings of its members and officers acting as a body corporate and politic hereby are declared to be of the same full, complete and binding force and effect as such acts and doings would have been were the name of the Harry G. Decker Post No. 51, The American Legion now on the list of corporations in the office of the secretary of state (and were the copy of the certificate of organization of said Harry G. Decker Post No. 51, The American Legion now in the files of such office) in accordance with the provisions of the statutes of Maine in such case made and provided after the certificate of organization was recorded April 28, 1925 in Book 619, Page 588 of the Kennebec Registry of Deeds following the approval of the certificate and the purposes of said corporation by the attorney-general on April 28, 1925. The secretary of state is hereby directed to receive and enter on the records of said office "that the certificate of the organization of the Harry G. Decker Post No. 51, The American Legion, a corporation organized under chapter 62, of the revised statutes of 1916, has been filed in this office and that said corporation is duly organized according to law", and the secretary of state is hereby directed to amend the list of corporations and make the necessary entries thereon relative to the aforesaid post.
- Sec. 2. Conveyances and other instruments in writing made valid and binding. All conveyances, transfers and other documents and instruments in writing heretofore executed by the officers of said organization as a body corporate for and in the name of Harry G. Decker Post No. 51, The American Legion, are hereby declared to be valid and binding on the corporation. All conveyances, grants and transfers of title of property real and personal, heretofore made to said Harry G. Decker Post No. 51, The American Legion, as a corporation, are hereby declared to have the same force and effect as such conveyances, grants and transfers would have, were the name of said corporation now on the list and the certificate of its organization filed in the office of the secretary of state on said April 28, 1925.
