PRIVATE AND SPECIAL, 1945

#### Chapter 25

AN ACT to Authorize Penobscot County Water Company to Supply the Inhabitants of the Town of Eddington with Water for Domestic and Other Purposes.

Be it enacted by the People of the State of Maine, as follows:

Penobscot County Water Company authorized to supply water to the town of Eddington. Penobscot County Water Company, a corporation organized under the general laws of the state of Maine, now engaged in supplying the inhabitants of the city of Brewer in the county of Penobscot and state of Maine and others with water for domestic, municipal and other purposes, is hereby further authorized to supply the inhabitants of the town of Eddington in said county with water for domestic, municipal and such other purposes as may be or become necessary and/or expedient, including but not limited to the extinguishment of fires; and for the purposes aforesaid said Penobscot County Water Company is hereby authorized to extend its pipes, conduits and mains from and through the city of Brewer to and into the town of Eddington, and to construct, lay, re-lay, build, maintain and renew therein any and all pipes, pipe lines, conduits, mains, hydrants, fixtures, buildings and structures necessary or convenient for any of its said purposes and/or to renew or remove any of the same as occasion may require; and for the purposes aforesaid said Penobscot County Water Company may exercise therein and therefor every right of eminent domain and every other franchise, right and power that it now possesses and/or which have heretofore been confirmed to it by chapter 57 of the private and special laws of the state of Maine for the year 1923, which rights, privileges, franchises and powers are hereby granted to it with respect to the conduct of its business in the town of Eddington as though specifically set forth herein; all however subject to the conditions, provisions and limitations set forth in said chapter 57 of the private and special laws of 1923.
