Chapter 114

AN ACT Relating to Salary of the Judge and the Recorder of the Waldo County Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1941, c. 12, § 2, amended. The 2nd sentence of section 2 of chapter 12 of the private and special laws of 1941 is hereby amended to read as follows:

'Said judge shall receive a salary of ~~\$1,400~~ \$1,500 per year and said recorder shall receive a salary of ~~\$600~~ \$700 per year for all services in criminal and civil cases, to be paid from the treasury of the county of Waldo in monthly payments on the last day of each month.'

Chapter 115

AN ACT to Establish the Western Oxford Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Name and territorial jurisdiction; judge to be resident of district. There shall be, and hereby is, established a municipal court in, and for, the towns of Fryeburg, Lovell, Stow, Brownfield, Denmark, Hiram and Porter, in the county of Oxford and state of Maine, said towns constituting a municipal district to be denominated as the "Western Oxford Municipal Court", which shall be a court of record and have a seal; to consist of 1 judge, who shall be an attorney at law in good standing, who shall be appointed in accordance with the constitution of the state, and said judge shall be a resident of said municipal district at the time of his appointment and during his continuance in office and shall keep the records of said court.

Sec. 2. Jurisdiction, civil and criminal. This court shall have jurisdiction over all other matters, civil and criminal, in the county of Oxford in accordance with the provisions of law which govern municipal courts in this state.

Sec. 3. Concurrent jurisdiction with superior court in civil actions. Said court shall have concurrent jurisdiction with the superior court of Oxford
