Chapter 69

RESOLVE, Appropriating Money to Repair Fish Screen at Eagle Lake.

Fish screen at Eagle lake; repairing of. Resolved: That the sum of \$2,500 be, and hereby is, appropriated to be taken from the general fund of the state for the purpose of repairing the fish screen at the outlet of Eagle lake in the county of Aroostook; said fund to be expended under the direction of the commissioner of inland fisheries and game.

Effective July 21, 1945

Chapter 70

RESOLVE, in Favor of Velma Norton, of Caribou.

Velma Norton; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$60 to be paid to Velma Norton of Caribou, as a full and final settlement for her claim against the state for damage to 6 angora rabbits killed by a dog; said sum to be paid from the general fund of the state.

Effective July 21, 1945

Chapter 71

RESOLVE, in Favor of Alphonso S. Dube of Togus.

Alphonso S. Dube; bonus for. Resolved: That there be, and hereby is appropriated from the general fund of the state the sum of \$100 to be paid to Alphonso S. Dube, of Togus, as a bonus for World War service.

Chapter 72

RESOLVE, in Favor of Mrs. Doris G. Cummings of Perry.

Mrs. Doris G. Cummings; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$309 to be paid to Mrs. Doris G. Cummings, of Perry, for services to the state of Maine, as Acting Indian Agent

for the Passamaquoddy and Penobscot tribes of Indians from February 8, 1943 to May 22, 1943, said sum to be paid from the general fund of the state.

Chapter 73

RESOLVE, to Reimburse the Town of Amherst for Suppression of a Forest Fire.

Town of Amherst; reimbursed. Resolved: That the sum of \$2279.93 be, and hereby is, appropriated to be paid to the town of Amherst, to reimburse said town for suppression of a forest fire in August, 1944; said sum to be paid from the general fund of the state.

Effective July 21, 1945

Chapter 74

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Lands in Oxford County to Fred L. Edwards, of Bethel.

Forest commissioner authorized to convey certain lands. Resolved: That the forest commissioner be, and hereby is, authorized to convey to Fred L. Edwards, of Bethel, whatever interest the state has in Lot 7, R. 3, part Lot 6, R. 3, and part Lots 6 and 7, R. 2, Fryeburg Academy Grant in Mason, containing 235 acres, for the sum of \$225.39.

Chapter 75

RESOLVE, Relating to Daily Bag Limit from Androscoggin Watershed above Middle Dam.

Daily bag limit from Androscoggin watershed. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation limiting the daily bag limit, unless otherwise restricted, to 6 fish per person per day in the aggregate from all waters in
