Chapter 78

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Land in Somerset County to J. Russell MacArthur, of Jackman.

Forest commissioner authorized to make sale. Resolved: That the forest commissioner be, and hereby is, authorized to convey to J. Russell MacArthur, of Jackman, whatever interest the state has in 8.75 acres in 6 R 1 NBKP, for the sum of \$945.55.

Chapter 79

RESOLVE, Regulating Fishing for Atlantic Salmon in Narraguagus River and Its Tributaries.

Narraguagus river and its tributaries; fishing for Atlantic Salmon regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation that no fish may be taken from the Narraguagus river and its tributaries in the towns of Cherryfield, Deblois and Beddington, in the county of Washington, except by using a single hook on a line.

No person shall take or have in his possession more than 2 Atlantic salmon taken from these waters in any one day.

From Stillwater Dam in Cherryfield to the mouth of the river, fishing for Atlantic salmon is permitted until September 30.

Chapter 80

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Lands in Oxford County to Fred L. Edwards, of Bethel.

Forest commissioner authorized to convey certain lands. Resolved: That the forest commissioner be, and hereby is, authorized to convey to

Fred L. Edwards, of Bethel, whatever interest the state has in land in 433 acres in lot 7, R. 8; lot 9, R. 7; lot 8, R. 7; lot 8, R. 8; lot 8, R. 3; lot 10, R. 8; lot 7, R. 6; and lot 8, R. 6; Oxford county for the sum of \$853.25.

Chapter 81

RESOLVE, for Maintenance and Development of Public Park Facilities.

Maintenance and development of public park facilities. Resolved: That there be, and hereby is, appropriated the sum of \$50,000 from unappropriated surplus for the maintenance and development of public park facilities, to be expended by and under the supervision of the Maine state park commission; and be it further

Resolved: That any unexpended balances shall not lapse, but shall remain as a continuing carrying account until the purposes of this resolve have been accomplished.

Chapter 82

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Lands in Penobscot County to Donald L. Haskell, of Old Town.

Forest commissioner authorized to convey certain lands. Resolved: That the forest commissioner be, and hereby is, authorized to convey to Donald L. Haskell, of Old Town, whatever interest the state has in lot 35, River lots 7 and 8, east of main highway in Argyle township, Penobscot county, containing 20 acres more or less, for the sum of \$22.11.
