Chapter 51

AN ACT Relating to Licensing of Motion Picture Operators.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 88, § 67, amended. Section 67 of chapter 88 of the revised statutes is hereby amended to read as follows:

'Sec. 67. No person to operate without a license; operator to be 18 years of age and thoroughly skilled; fee. No person shall operate any cinematograph or similar apparatus in any city or town until he has received a license or permit to do so from the insurance commissioner; no such license to operate a cinematograph or similar apparatus shall be granted to any person under 18 years of age, nor until the applicant shall have satisfied the insurance commissioner that he is thoroughly skilled in the mechanical and electrical apparatus or devices used in the operation of a cinematograph or similar apparatus. A fee therefor of not more than \$5 shall be fixed by the insurance commissioner for the examination; and a fee in an amount not in excess of \$5 shall be fixed by the insurance commissioner for each license.'

Chapter 52

AN ACT Relating to Payment to Oxford County Law Library.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 151, amended. That part of section 151 of chapter 79 of the revised statutes, which relates to Oxford county, as repealed and replaced by chapter 253 of the public laws of 1945, is hereby amended to read as follows:

'Oxford, \$500 \$1,000,'
