## Chapter 157

### AN ACT Relating to the Salaries of Various Officers in Aroostook County.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., c. 79, § 6, amended.** That part of section 6 of chapter 79 of the revised statutes which relates to the salary of the county commissioners of Aroostook county is hereby amended to read as follows:

'Aroostook, \$1,100, except that 1 member of the board, to be designated by the board, who shall devote each full working day to his duties including superintendence of the county buildings, shall receive annually the sum of ~~\$2,000~~ \$3,000.'

**Sec. 2. R. S., c. 79, § 114, amended.** That part of section 114 of chapter 79 of the revised statutes which relates to the salary of clerk of courts in Aroostook county is hereby amended to read as follows:

'Aroostook, ~~\$2,800~~ \$4,000.'

**Sec. 3. R. S., c. 79, § 146, amended.** That part of section 146 of chapter 79 of the revised statutes which relates to the salary of county treasurer in Aroostook county is hereby amended to read as follows:

'Aroostook, ~~\$1,500~~ \$2,000.'

**Sec. 4. R. S., c. 79, § 165, amended.** That part of section 165 of chapter 79 of the revised statutes which relates to the salary of sheriff of Aroostook county is hereby amended to read as follows:

'Aroostook, ~~\$2,500~~ \$3,500.'

**Sec. 5. R. S., c. 79, § 231, amended.** That part of section 231 of chapter 79 of the revised statutes which relates to the salary of register of deeds in Aroostook county is hereby amended to read as follows:

'Aroostook, northern registry, ~~\$1,300~~ \$1,800; southern registry, ~~\$1,800~~ \$2,300.'

**Sec. 6. R. S., c. 140, § 3, amended.** That part of section 3 of chapter 140 of the revised statutes which relates to the salary of judge of probate in Aroostook county is hereby amended to read as follows:

'Aroostook, ~~\$2,500~~ \$3,500.'
