Chapter 209

AN ACT Relating to Salary of Clerks in the Office of Clerk of Courts in Kennebec County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 269, amended. That part of section 269 of chapter 79 of the revised statutes relating to clerk hire in the office of clerk of courts in Kennebec county is hereby amended to read as follows:

'for clerks in the office of clerk of courts, ~~\$1,500~~ \$2,200;'

Chapter 210

AN ACT to Increase the Salary of the Clerk of Courts in Penobscot County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes, which relates to the salary of the clerk of courts in Penobscot county, as amended by section 1 of chapter 206 of the public laws of 1945, is hereby further amended to read as follows:

'Penobscot, ~~\$2,700~~ \$3,000;'

Chapter 211

AN ACT Relating to the State School for Boys.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 23, § 75, amended. Section 75 of chapter 23 of the revised statutes is hereby amended to read as follows:

'Sec. 75. Commitments to the school, and to alternative punishment; deaf and dumb, non compos, or insane not to be sent; records. When a boy between the ages of ~~11~~ 9 and 17 years is convicted before any court or trial justice having jurisdiction of the offense, of an offense punishable by imprisonment in the state prison, not for life, or in the county jail, or in the house of correction, such court or justice may order his commitment to the state school for boys or sentence him to the punishment provided by

law for the same offense. If to such school, the commitment shall be conditioned that if such boy is not received or kept there for the full term of his minority, unless sooner discharged by the department as provided in section 78, or released on probation as provided in section 80, he shall then suffer the punishment provided by law, as aforesaid, as ordered by the court or justice; but no boy shall be committed to said school who is deaf and dumb, non compos, or insane. The record in the event of conviction in all such cases shall be that the accused was convicted of juvenile delinquency, and the court shall have power at the hearing of any such case to exclude the general public other than persons having a direct interest in the case. The records of any such case by order of the court may be withheld from indiscriminate public inspection, but such records shall be open to inspection by the parent or parents of such child or lawful guardian or attorney of the child involved.'

Chapter 212

AN ACT Relating to Salary of Register of Deeds in Knox County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 231. That part of section 231 of chapter 79 of the revised statutes, which relates to the salary of the register of deeds in Knox county is hereby amended to read as follows:

'Knox, ~~\$1,650~~ \$2,000.'

Chapter 213

AN ACT Relating to the Salaries of the Clerks in the County Offices of Knox County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 269, amended. That part of section 269 of chapter 79 of the revised statutes which relates to Knox county is hereby amended to read as follows:

'Knox county: for clerks in the office of register of deeds, ~~\$1,040~~ \$2,620; for clerks in the office of register of probate, ~~\$830~~ \$1,920; for clerks in the office of clerk of courts, ~~\$1,040~~ \$2,320; for clerk hire in the office of the county treasurer, \$180.'
