used by any school for drinking or culinary purposes and is taken from sources other than a municipal water system. If such water is found to be contaminated, polluted, and unfit for domestic use, the department may issue an order prohibiting the use or supplying of such water to any school as long as such contamination, pollution and unfitness remains. The department shall charge the average cost of the analysis for such examination to the municipality required to have such test made.'

AN ACT Relating to Salary of Register of Probate in York County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 140, § 22, amended. That part of section 22 of chapter 140 of the revised statutes relating to the salary of the register of probate in York county is hereby amended to read as follows:

'York, ~~\$2,100~~ \$2,400.'

Chapter 307

AN ACT Increasing the Salary of Register of Deeds of York County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes relating to the salary of the register of deeds of York county is hereby amended to read as follows:

'York, ~~\$1,750~~ \$2,500.'

Chapter 308

AN ACT Relating to Election of Town Auditors.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 80, § 15, amended. Section 15 of chapter 80 of the revised statutes is hereby amended to read as follows:

'Sec. 15. Officers chosen by ballot. Moderator, town clerk, selectmen, assessors, ~~and~~ overseers of the poor, treasurer ~~auditor~~ and school committee shall be elected by ballot; and the other said officers may be elected by ballot or, if not so elected, they shall be appointed by the selectmen.'

Chapter 309

AN ACT Relating to Salary of the Register of Deeds of Kennebec County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes, as amended by chapter 141 of the public laws of 1945, which relates to the salary of the register of deeds of Kennebec county, is hereby further amended to read as follows:

'Kennebec, ~~\$2,200~~ \$2,700.'

Chapter 310

AN ACT Relating to Regulation of Smelt Fishing in Casco Bay.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 34, § 35, amended. Section 35 of chapter 34 of the revised statutes is hereby amended by adding at the end thereof a new paragraph to read as follows:

'No smelts shall be taken or fished for in any of the tidal waters of Casco bay between the 1st day of April and the 15th day of September except by hook and line.'
