## Chapter 383

### AN ACT Increasing the Salaries of the County Attorney and Assistant County Attorney of Cumberland County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of county attorney and assistant county attorney of Cumberland county is hereby amended to read as follows:

'Cumberland, ~~\$2,600~~ \$3,500; assistant county attorney, ~~\$1,800~~ \$2,500.'

## Chapter 384

### AN ACT to Provide a Retirement System for State Employees.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., c. 37, §§ 215-218, inclusive, 218-A, 218-B, 218-C, and 220-241, inclusive, repealed. Sections 215 to 218, inclusive, sections 218-A, 218-B and 218-C, as enacted by section 4 of chapter 239 of the public laws of 1945, and sections 220 to 241, inclusive, as amended, of chapter 37 of the revised statutes, are hereby repealed.

Sec. 2. R. S., c. 60, §§ 1-4, inclusive, 7-14, inclusive, and 16-19, inclusive, repealed. Sections 1 to 4, inclusive, as amended, sections 7 to 14, inclusive, as amended, and sections 16 to 19, inclusive, of chapter 60 of the revised statutes, are hereby repealed.

Sec. 3. R. S., c. 60, revised. Chapter 60 of the revised statutes, as amended, is hereby revised to read as follows:

#### 'STATE EMPLOYEES' RETIREMENT SYSTEM.

Sec. 1. Definitions. "Retirement system" shall mean the State Employees' Retirement System of the state of Maine, as defined in section 2.

"Board of trustees" shall mean the board provided for in section 12 to administer the retirement system.

"Department" shall mean any department, commission, institution or agency of the state government.

"Employee" shall mean any regular classified or unclassified officer or employee in a department, including teachers in the state teachers' col-
