## Chapter 101

### AN ACT Relating to Qualifications of Ward Officials in the City of Lewiston.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1939, c. 8, Art. I, § 2, amended. Section 2 of article I of chapter 8 of the private and special laws of 1939 is hereby amended to read as follows:

'Sec. 2. City council and board of aldermen created. The administration of all fiscal, prudential and municipal affairs of said city, except as otherwise herein provided, shall be vested in 1 body to be denominated and known as the city council, which body shall consist of 1 principal magistrate to be styled the mayor who shall be an inhabitant of said city qualified to vote therein and 1 council of 7 to be denominated the board of aldermen, each of whom shall ~~be an inhabitant~~ have been a legal voter for at least 1 year of the ward wherein he is chosen, qualified to vote therein.'

## Chapter 102

### AN ACT to Incorporate the Town of New Gloucester School District.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. Incorporation; name; purposes. Subject to the provisions of sections 7 and 9 hereof, the inhabitants of and the territory within the town of New Gloucester are hereby created a body politic and corporate under the name of "Town of New Gloucester School District" for the purpose of acquiring property within the said town for school and related athletic and recreational purposes; for the purpose of erecting, enlarging, repairing, equipping and maintaining on said property a school building or school buildings and related athletic and recreational facilities; for the purpose of purchasing school busses; for the purpose of completing, grading, furnishing, rebuilding, renovating and otherwise bettering the condition of any or all buildings within said town used for school purposes or which may hereafter be used for school purposes; for the purpose of leasing or letting any property of said district to said town for the purpose of receiving, accepting and holding gifts, grants or devises of property real, personal or mixed to be used for school and related athletic and recreational purposes; all for the benefit of the inhabitants of said town.
