mitting its acceptance or rejection by the legal voters of the city of Augusta at the next regular state or city election. For the purposes of such election the city clerk shall reduce the subject matter of this act to the following question: "Shall the Act to Amend the Charter of the City of Augusta by Providing for the Appropriation of School Funds by the City Council be accepted?" and the voters shall indicate by a cross placed against the words "Yes" or "No" their opinion of the same. This act shall take effect for all the purposes hereof immediately upon its acceptance by a majority vote of the legal voters voting at said election. The result of the vote shall be declared by the municipal officers of the city of Augusta and due certificates thereof filed by the city clerk with the secretary of state.

Chapter 159

AN ACT to Incorporate the Orono-Veazie Water District.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Territorial limits; name; purposes. The area included within the combined territorial limits of the towns of Orono and Veazie in the county of Penobscot and the inhabitants therein, is hereby created a body politic and corporate by the name of Orono-Veazie Water District, for the purpose of supplying the inhabitants of said district with water for domestic, sanitary, commercial and municipal purposes.

Sec. 2. Source of supply. The said water district, for the purposes of its incorporation, is hereby authorized to take, collect, store, flow, use, detain, distribute and convey to and in the towns of Orono, Veazie, or both, water from Chemo lake and its tributaries in the town of Bradley and the city of Brewer; from Eaton brook and its tributaries in the city of Brewer and the towns of Eddington and Holden; from Hatcase pond in the towns of Dedham and Eddington and/or from Sweets pond in the town of Orrington, or such other source of supply as is approved by the public utilities commission or to contract to do all or any of the foregoing.

Sec. 3. May exercise eminent domain. The said district, for the purposes of its incorporation, is hereby authorized to take and hold, as for public uses, by purchase or otherwise, including by right of eminent domain, in the city of Brewer and the towns of Orono, Veazie, Bradley, Holden, Eddington, Dedham and Orrington any lands or interests in land or water rights necessary for erecting and maintaining dams, for flowage, for power for pumping its water supply through its mains, for reservoirs, for preserving the purity of the water and watershed, for laying and maintaining

aqueducts and other structures for taking, distributing, discharging and disposing of water and for rights of way or roadways to, its sources of supply, dams, power stations, reservoirs, mains, aqueducts, structures and lands.

The said district is hereby authorized to lay in and through the streets, roads, ways and highways of the city of Brewer and the towns of Orono, Veazie, Bradley, Holden, Eddington, Dedham and Orrington and across private lands therein, and to maintain, repair and replace all such pipes, aqueducts, and fixtures as may be necessary and convenient for its corporate purposes, and whenever said district shall lay any pipes, or aqueducts in any street, road, way or highway it shall cause the same to be done with as little obstruction as practicable to the public travel; and shall at its own expense without unnecessary delay cause the earth and pavement removed by it to be replaced in proper condition.

The said district is hereby authorized, for the purposes of its incorporation, to erect and maintain all dams, reservoirs and structures necessary and convenient for its corporate purposes. Provided, however, nothing herein contained shall be construed as authorizing said water district to take by right of eminent domain any of the property or facilities of any other public service corporation or district used or acquired for future use by the owner thereof in the performance of a public duty unless expressly authorized thereto herein or by subsequent act of the legislature, or as provided in section 9 hereof.

Sec. 4. Procedure in exercising right of eminent domain and adjustment of damages. The said district in exercising, from time to time, any right of eminent domain conferred upon it by law or through or under the franchise of any water company by it acquired shall file written application with the public utilities commission requesting its approval of the proposed taking. Such application shall describe the property or rights to be taken, the purpose of the taking, and shall name all parties who may be interested therein; the commission thereupon shall appoint a time for a hearing near the premises, and shall require such notice as the commission may direct to be given to the persons interested at least 14 days before the date of the hearing; the commission then shall view the premises, hear the parties, and shall determine how much, if any, of the property described in the petition should be taken for the reasonable purposes of the water district and for the safe, economical and efficient furnishing of an adequate water supply; and in authorizing any taking the commission may attach such reasonable terms, limitations and restrictions as justice may require. If the commission shall find that any of the property described in the application is necessary for the aforesaid purposes of the district, it shall make a certificate containing a definite description of the property to be

taken, and of any terms, restrictions and limitations in connection therewith, and shall furnish to the district a true copy thereof, attested by the clerk of the commission; and when such copy of the certificate is filed with the clerk of courts in the county where the property lies, the property shall be deemed and treated as taken; provided, however, that when property is held by a tenant for life and the reversion is contingent as to the persons in whom it may vest at the termination of the life estate, such fact shall be stated in the application and the commission, in addition to the notice to the tenant for life, shall require notice by publication, in such manner as it may deem proper, to all others interested. Entry may be made on any private land prior to the filing of any such application for the purpose of making surveys, the district being responsible for any damage resulting from such entry, and possession may be had of the property described in the certificate of the commission forthwith upon the filing and recording of such certificate as hereinbefore provided, but title to such property shall not vest in the district until payment therefor has been made.

If any person sustaining damages by any taking as aforesaid shall not agree with the district upon the sum to be paid therefor, either party upon petition to the county commissioners of Penobscot county may have such damages assessed by them. The procedure and all subsequent proceedings and right of appeal therefrom shall be had under the same restrictions, conditions and limitations as are or may be by law prescribed in the case of damages by the laying out of highways.

Sec. 5. Procedure if public utility must be crossed. In case of any crossing of any public utility, unless consent is given by the company owning or operating such public utility as to place, manner and conditions of the crossing within 30 days after such consent is requested by said district, the public utilities commission shall determine the place, manner and conditions of such crossing; and all work on the property of such public utility shall be done under the supervision and to the satisfaction of such public utility, but at the expense of the district.

Sec. 6. Board of trustees. All the affairs of said district shall be managed by a board of 3 trustees, residents therein, who shall be appointed, 2 by the municipal officers of Orono and 1 by the municipal officers of Veazie, provided that if either of said towns fails to approve this act as hereinafter provided while the other of said towns approves this act, then the whole board shall be appointed by the municipal officers of the approving town. They shall hold office for the term of 3 years and until their respective successors are appointed and qualified, except, however, as hereinafter provided.

Sec. 7. Trustees; how appointed; meetings; officers; vacancies filled for the unexpired term. The first board of trustees shall be appointed within

3 days after the meeting of the voters of said district to accept this act, 1 to serve until the 1st annual meeting of the district, 1 until the 2nd and 1 until the 3rd such meeting. Thereafterward, in the month of March in each year, 1 member shall be appointed to serve for the term of 3 years by the municipal officers of the town, the term of whose representative is expiring. As soon as convenient after the trustees are first appointed the trustees shall hold a meeting at some convenient place in the district to be called by any member thereof in writing designating the time and place and delivered in hand to the other 2 members not less than 2 full days before the meeting; provided, however, that they may meet by agreement without such notice. They shall then organize by the election of a chairman and clerk from their own number, adopt a corporate seal and by-laws, and perform any other acts within the powers delegated to them by law. When necessary they may choose a treasurer and other needful officers and agents who shall serve at their pleasure, and whose compensation shall be fixed by said trustees. The treasurer shall furnish bond in such sum and with such sureties as they may approve. Members of the board shall be eligible to any office under the board, but shall not receive any compensation therefor except as trustees.

The compensation of the trustees shall be \$50 each per annum unless otherwise provided by vote as above defined.

The trustees shall be sworn to the faithful performance of their duties as such, which shall include the duties of any member as clerk or clerk pro tem. They shall make and publish an annual report including a report of the treasurer.

Sec. 8. District and city authorized to make contracts. Said district through its trustees is authorized to contract with persons and corporations, including the towns of Orono and Veazie, which towns are authorized to contract with it for the supply of water for municipal purposes.

Sec. 9. Authorized to acquire property and franchises of Penobscot County Water Company. Said water district is hereby authorized and empowered to acquire by purchase or by the exercise of the right of eminent domain, which right is hereby expressly delegated to said district for said purpose, the entire plant, properties, franchises, rights and privileges, except cash assets and accounts receivable, owned by the Penobscot County Water Company, including all lands, waters, water rights, dam structures, reservoirs, pipes, machinery, fixtures, hydrants, tools and all apparatus and appliances used or usable in supplying water in the towns of Orono and Veazie. Said company is hereby authorized to sell, transfer, and convey its franchises and property to said water district.

Sec. 10. Procedure in case trustees and water company fail to agree on

terms of purchase. In case said trustees fail to agree with said Penobscot County Water Company upon the terms of purchase of the above mentioned property, on or before January 1, 1948, said district, through its trustees aforesaid, is hereby authorized to take said plant, property and franchises, as for public use by petition therefor in the manner hereinafter provided. And said water district, through its trustees, is hereby authorized on or before July 1, 1949, to file a petition in the clerk's office of the supreme judicial court for the county of Penobscot, in term time or in vacation, addressed to any justice of said court, who, after due notice to said Penobscot County Water Company and its mortgagees, shall, after hearing and within 30 days after the date at which said petition is returnable, appoint 3 disinterested appraisers, one of whom shall be learned in the law and none of whom shall be residents of Penobscot county, for the purpose of fixing a valuation of said plant, property and franchises. At the hearing aforesaid, such justice, upon motion of the petitioner, may order the production and filing in court, for the inspection of the petitioner, of all books and papers pertinent to the issue and necessary for a full understanding of the matter to be heard by said appraisers, the terms and conditions of so producing and filing such books and papers to be determined by the justice in his order therefor and to be enforced from time to time as any justice of supreme judicial court, in court time or in vacation, upon motion of either party, may deem reasonable and proper in the premises. At such hearing, such justice upon motion of the petitioner, may fix a time at which the said water company shall file in the clerk's office of the supreme judicial court for the county of Penobscot for the inspection of the petitioner, so far as they relate to the service in the towns of Orono and Veazie, the following: 1st, schedule showing the names, residences and water service of all its customers on the 1st day of January, next preceding the date of filing the petition, with the rate charged therefor; 2nd, copies of all contracts in force on said 1st day of January; 3rd, an itemized statement of the gross income earned during its last complete fiscal year and up to said 1st day of January, and all operating expenses and fixed charges, paid or incurred during such period and property chargeable thereto; 4th, a memorandum of all real estate, water rights, or interest therein, owned or controlled on said 1st day of January, with such brief description thereof as will reasonably identify the same; 5th, brief descriptions, specifications and plans of all reservoirs, mains, pipes, service pipes, hydrants, gates, gate boxes, shut-off boxes, fixtures and machinery and all the physical elements in such water system, giving in detail quantities, sizes, lengths, and specifying the streets, roads, or ways where situated; 6th, an itemized list of all tools, apparatus, appliances and supplies used or usable in supplying water on said 1st day of January. Such orders may be enforced from time to time by any justice of said supreme judicial court, in term time

or in vacation, upon motion of either party, as such justice may deem reasonable and proper in the premises. At such hearing the justice then sitting may, upon motion of the petitioner, make all such decrees as he deems reasonable and proper to enable the petitioner, through its servants and employees, to ascertain the true condition of the mains and pipes of the said water company, externally or internally, in the presence of the officers or agents of said water company, the entire expense thereof to be borne by said water district. The said appraisers shall have the power of compelling attendance of witnesses and the production of all books, accounts and papers pertinent to the issue and necessary for a full understanding by them of the matter in question and may administer oaths; and any witness or person in charge of such books, accounts and papers refusing to attend or to produce the same shall be subject to the same penalties and proceedings, so far as applicable, as witnesses summoned to attend the supreme judicial court. Depositions may be taken as in civil actions. The appraisers so appointed shall, after notice and hearing, fix the valuation of said plant, property and franchises at what they are fairly and equitably worth, so that said water company shall receive just compensation for all and the same. In fixing such valuation, the appraisers shall make full allowance to the Penobscot County Water Company for all damages occasioned to it by the severance of the plant, property and franchises so taken from the plant, property and franchises which are now owned, enjoyed and exercised by the Penobscot County Water Company under its present charter. The said 1st day of January, next preceding the date of the filing of the petition, shall be the date as of which the valuation aforesaid shall be fixed, from which date interest on said award shall run, and all rents and profits accruing thereafter shall belong to said water district. The report of said appraisers, or a majority of them shall be filed in said clerk's office, in term time or in vacation, as soon as may be after their appointment, and such single justice, or, in case of his inability to act, any justice of said court appointed by the chief justice, may, after notice and hearing, confirm or reject the same, or recommit it if justice so requires. Before a commission is issued to said appraisers either party may ask for instructions to said appraisers, and all questions of law arising upon said requests for instructions, or upon any other matters in issue, may be reported to the law court for determination before appraisers proceed to fix the valuation of the property, plant and franchises of said company. Upon the confirmation of said report the court so sitting shall thereupon after hearing, make final decree upon the entire matter, including the application of the purchase money and transfer of property, jurisdiction over which is hereby conferred, and with the power to enforce said decree as in equity cases. All findings of fact by said court shall be final, but any party aggrieved may take exceptions as to any ruling of law

so made, the same to be accompanied by so much of the case as may be necessary to a clear understanding of the question raised thereby. Such exceptions shall be claimed on the docket within 10 days after such final decree is signed, entered and filed and notice thereof has been given to the parties or their counsel, and said exceptions so claimed shall be made up, allowed and filed within said time unless further time is granted by the court or by agreement of the parties. They shall be entered at the next term of the law court to be held after the filing and entry of said decree and there heard unless otherwise agreed; or the law court for good cause shall order further time for hearing thereon. Before said plant, property and franchises are transferred in accordance with such final decree and before payment therefor, as hereinbefore provided such justice shall, upon motion of either party, after notice and hearing take account of all receipts and expenditures, properly had or incurred by the Penobscot County Water Company, from and after said 1st day of January, and all net rents and profits accruing thereafter, and shall order the net balance to be added to or deducted from, the amount to be paid under such final decree, as the case may be. All findings of fact by such justice at such hearing shall be final. On payment or tender by said district of the amount so determined and the performances of all the other terms and conditions so imposed by said court, the portion of plant, property and franchises of Penobscot County Water Company within the towns of Orono and Veazie used and usable in supplying water in the said towns of Orono and Veazie shall become vested in said water district. Either party may file and prosecute motions and petitions relating to the premises at any state of the proceedings, and the proceedings shall not be discontinued except upon consent of both parties.

Sec. 11. Valid contracts of water company to be assumed by district. All valid contracts now existing between the Penobscot County Water Company and any person or corporations for supplying water in the towns of Orono and Veazie shall be assumed and carried out by said Orono-Veazie Water District.

Sec. 12. Authorized to negotiate temporary loans; and to issue notes and bonds; declared a quasi-municipal corporation; notes and bonds legal investments for savings banks. For accomplishing the purposes of this act, said water district, through its trustees, is authorized to borrow money temporarily, and to issue therefor the interest-bearing negotiable notes of the district, and for the purpose of refunding the indebtedness so created, of paying any necessary expenses and liabilities incurred under the provisions of this act, including the expenses incurred in the creation of the district, in acquiring the aforesaid properties and franchises of the Penobscot County Water Company, by purchase or otherwise, of securing sources

of supply, taking water and land, paying damages, laying pipes, constructing, maintaining and operating a water plant and making extensions, additions and improvements to the same, the said district, through its trustees, may from time to time issue bonds of the district to an amount necessary in the judgment of the trustees therefor. Said notes and bonds shall be legal obligations of said water district, which is hereby declared to be a quasi-municipal corporation within the provisions of sections 132 and 133 of chapter 49 of the revised statutes of 1944, and all the provisions of said sections shall be applicable thereto. The said notes and bonds shall be legal investments for savings banks.

Sec. 13. Property tax exempt. The property of said district shall be exempt from all taxation in the towns of Orono and Veazie.

Sec. 14. Water rates; application of revenue; sinking fund. All individuals, firms and corporations, whether private, public or municipal, shall pay to the treasurer of said district the rates established by said board of trustees for the water used by them, and said rates shall be uniform within the territory supplied by the district and subject to approval of the public utilities commission. Said rates shall be so established as to provide revenue for the following purposes:

I. To pay current expenses for operating and maintaining the water system, and provide for such extensions and renewals as may become necessary.

II. To provide for the payment of the interest on the indebtedness created by the district.

III. To provide each year a sum equal to not less than 1% nor more than 10% of the entire indebtedness created by the district, which sum shall be turned into a sinking fund and there kept to provide for the extinguishment of said indebtedness. The money set aside for the sinking fund shall be devoted to the retirement of the obligation of the district or invested in such securities as savings banks are allowed to hold. Provided, however, that the trustees may, in their discretion and in lieu of the establishment of a sinking fund, issue the bonds of the district so that not less than 1% of the amount of the bonds so issued shall mature and be retired each year.

IV. If any surplus remains at the end of the year, it may be turned into the sinking fund.

Sec. 15. Incidental powers granted. All incidental powers, rights and privileges necessary to the accomplishment of the main object herein set forth are granted to the corporation hereby created; except that all provisions herein contained authorizing and empowering the purchase or taking by right of eminent domain of all or any of the franchises and prop-

erties of Penobscot County Water Company shall be and are hereby declared to be junior to and subject to rights previously granted by the legislature to Brewer Water District.

Sec. 16. Local referendum for towns of Orono and Veazie; meeting, how called; certificate to secretary of state. This act shall take effect 90 days after the adjournment of the legislature only for the purpose of permitting its submission to the legal voters of each of said towns of Orono and Veazie at a special meeting to be called and held for the purpose, in the 1st instance, not later than September 1, 1947, but only if the total number of votes cast for and against acceptance of this act at said special meeting equals or exceeds 20% of the total number of legal voters of said town, and the warrant for said town meeting shall contain in each case an article therein reading substantially as follows: To see if the inhabitants of the town will vote in favor of the following question: "Shall the Act to Create the Orono-Veazie Water District be accepted?"

If the act fails of approval in either of said towns, a second such town meeting may be similarly called and held for the same purpose in such town at any time not later than January 1, 1948, and if the inhabitants of said town by a majority vote at said second town meeting approve the act, the act shall take effect as if it had been so approved at the first meeting.

The results of said town meeting shall be declared by the municipal officers and due certificates thereof shall be filed with the secretary of state by the clerks of said towns respectively.

Sec. 17. Act void unless property of water company is acquired. If said water district shall fail to purchase or file its petition to take by eminent domain, before July 1, 1949, as in this act provided, the plant properties, franchises, rights and privileges owned by the Penobscot County Water Company and used or usable in supplying water in the towns of Orono and Veazie, then this act shall become null and void, except that the corporate entity shall continue until all obligations and liabilities incurred under the provisions of section 12 have been settled in full or otherwise enforced pursuant to the provisions of said section 12 and the provisions of said section 12 for the enforcement of obligations and liabilities shall continue applicable.

Sec. 18. Costs and expenses of taking, directed by court. All costs and expenses of the taking of the property of the Penobscot County Water Company arising under the provisions of this act shall be paid and borne as directed by the court in the final decree provided by section 10.

Sec. 19. Existing statutes not affected; rights conferred subject to provisions of R. S., c. 40. Nothing herein contained is intended to repeal, or shall be construed as repealing, the whole or any part of any existing

statute, and all the rights and duties herein mentioned shall be exercised and performed in accordance with all the applicable provisions of chapter 40 of the revised statutes of 1944, and all acts amendatory thereof or additional thereto.

Chapter 160

AN ACT to Create the Waterville Sewerage District.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Incorporation. The territory and people constituting the city of Waterville shall constitute a body politic and corporate under the name of the Waterville Sewerage District. The purpose of said district shall be to take over, control, manage and operate the drains and sewers now owned by the city of Waterville, to extend, increase, enlarge and improve said drains and sewers, to extend the present system or systems so as to furnish sewerage facilities to portions of the city not now served with such facilities, to provide for surface drainage as well as removal of sewage and to provide for disposal of sewage in whole or in part by other means than emptying it into rivers when, as and if such disposal becomes necessary, and generally to provide a system of sanitation sewerage and drainage and storm sewerage and drainage for public purposes and for the health, comfort and convenience of the inhabitants of said district.

Sec. 2. Authority to acquire and hold property; right of eminent domain conferred. Upon acceptance of this act as hereinafter provided title to all public drains and sewers in the city of Waterville shall pass to and vest in said district and for the purpose of providing a system of sewers and drainage for the comfort, convenience and health of the inhabitants of said district, the said district is hereby authorized and empowered to acquire and hold real estate and personal estate necessary and convenient for the purposes aforesaid, and is hereby authorized to take and hold by purchase, lease or the exercise of the right of eminent domain, as hereinafter provided, or otherwise, any land or real estate or easement therein necessary for forming basins, reservoirs and outlets; for erection of buildings for pumping works and sewage treatment and for laying pipes and maintaining same and for laying and maintaining conduits for carrying and collecting, discharging and disposing of sewage matter and waters and for other objects necessary, convenient and proper for the purposes of this act, and all of which property, wherever located shall be exempt from taxation.
