RESOLVES, 1947**CHAP. 8**

said S. line and parallel with N. line of said township, to S. E. corner of said 20-acre lot; thence S. along W. line of said John Myrick house lot to point of beginning, in T. 1 North Division, Penobscot county, containing 22 acres, more or less, for the sum of \$35.18.

Chapter 6

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Oxford County to Calvin Cummings of Bethel.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Calvin Cummings, of Bethel, whatever interest the state has in a lot in lot 4, R. 3, bounded: N. and W. by L. N. Kimball, E. and S. by road, with buildings, containing 24 acres more or less, in Albany township, Oxford county, for the sum of \$25.

Chapter 7

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Penobscot County to Carl J. Kennedy of Milford.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Carl J. Kennedy, of Milford, whatever interest the state has in a lot in lot 41, River lot 9, bounded N. by Ernest Ladd and Winfield Spencer, E. by Penobscot river, S. by town land, W. by Leroy Weymouth, with buildings, in Argyle township, Penobscot county, containing 68 acres, more or less, for the sum of \$127.81.

Chapter 8

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Washington County to Harry L. Wheelden, of Bangor.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Harry L.

Wheelden, of Bangor, whatever interest the state has in section 26, N. W. $\frac{1}{4}$ section 23, according to plan by H. R. Taylor, in T. 24 Middle Division, Washington county, containing 800 acres, more or less, for the sum of \$453.

Chapter 9

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Penobscot County to Davidson Land Company.

State tax assessor authorized to make sale. **Resolved:** That the state tax assessor be, and hereby is, authorized to make, execute and deliver to Davidson Land Company a deed in the name of the state, of all interest of the state in the following described property: T. 2, R. 6, W. E. L. S. (Herseytown), Penobscot county, all, with mill, farm and other improvements, but with the exception of lots 12, 36, 108, 119, 120, 131, 132, 144 and farm lots, containing 23,301 acres, more or less, for the sum of \$6,347.41.

Chapter 10

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Aroostook County to Gerard Albert of St. Agatha.

State tax assessor authorized to convey certain lands. **Resolved:** That the state tax assessor be, and hereby is, authorized to convey to Gerard Albert, of St. Agatha, whatever interest the state has in an undivided interest in lot 13 and half lot 14 in N. half, according to plan of N. half by Joseph Sewall in 1886, in T. 17, R. 4, W. E. L. S. Aroostook county, containing 110 acres, more or less, for the sum of \$430.10.
