#### Chapter 18

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Aroostook County to Ralph M. Robinson, of Sherman Mills.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Ralph M. Robinson of Sherman Mills, whatever interest the state has in a farm lot in the northeast part of T. 7, R. 5, W. E. L. S. Aroostook county, lying on both sides of the Ashland and Patten road, as shown by a survey and plan of said township made by Cobb & Robinson in 1900, containing 100 acres, more or less, for the sum of \$115.89.

#### Chapter 19

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Piscataquis County to Mabel I. Lafland of Medford Township.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Mabel I. Lafland of Medford Township, whatever interest the state has in undivided ½ lots E and W, N. of river in W. half of town, with buildings, (59A); also W. half of lot 53 and W. part of lot K, N. of river in W. half of town (56 A.), in Medford Township, Piscataquis county, containing 115 acres, more or less, for the sum of \$70.10.

#### Chapter 20

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Washington County to Alvah B. Alexander, et als. of South Gardiner.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Alvah B. Alexander, et als. of South Gardiner, whatever interest the state has in a cottage lot bounded N. by Eastern Pulpwood Co.; E. and S. by Carlow
