Chapter 32

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Aroostook County to Fred Marquis, of Sinclair.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Fred Marquis, of Sinclair, whatever interest the state has in lots 29 and 30 in N. half, according to plan by Joseph Sewall in 1886, with buildings, in T. 17, R. 4, W. E. L. S., Aroostook county, containing 59 acres, more or less, for the sum of \$200.

Chapter 33

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Oxford County to Dr. W. B. Twaddle, of Bethel.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Dr. W. B. Twaddle, of Bethel, whatever interest the state has in lots 2, 3 and 5, R. 6, and part lot 8, R. 3, Fryeburg Academy Grant in Mason Township, Oxford county, containing 389 acres, more or less, for the sum of \$568.51; also 80 acres in lot 2, R. 10, 160 acres in lot 1, R. 7, 60 acres in lot 2, R. 9, 160 acres in lot 3, R. 9, 80 acres in lot 2, R. 7, 160 acres in lot 2, R. 8, 100 acres in lot 1, R. 6, in Albany Township, Oxford county, containing 800 acres, more or less, for the sum of \$2,212.92.

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Aroostook County to Wilfred Rossignol of Guerette (P. O. Stockholm).

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is authorized to convey to Wilfred Rossignol, of Guerette (P. O. Stockholm) whatever interest the state has

Chapter 35

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Oxford County to John Westleigh of Mason.

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to John Westleigh, of Mason, whatever interest the state has in W. part lot 1, R. 11, in Albany township, Oxford county, containing 60 acres, more or less, for the sum of \$121.27.

Chapter 36

RESOLVE, Designating an Expiration Date for the Civilian Defense Act.

Expiration date of Civilian Defense Act, designated. Resolved: That in accordance with section 13 of chapter 305 of the public laws of 1941, "An Act to Create the Maine Civilian Defense Corps and Provide for the Safety of the State in Time of War," the day which is 90 days after the adjournment of this legislature is hereby designated as the date upon which said act shall cease to remain in force.

Chapter 37

RESOLVE, Proposing an Amendment to the Constitution Providing for Additional Signers in Petitions for Referendum.

Constitutional amendment. Resolved: Two-thirds of each branch of the legislature concurring, that the following amendment to the constitution of this state is hereby proposed:

Constitution, Art. IV, part third, § 17, amended. Section 17 of part third of Article IV of the constitution of the state is hereby amended to read as follows:
