**RESOLVES**

OF THE

**STATE OF MAINE**

As Passed by the Ninety-third Legislature

for the sum of \$100, the perpetual right and easement to enter at any and all times upon a strip of land 150 feet in width owned by the state of Maine and located in the town of Hebron, county of Oxford and said state, and to erect, construct, maintain, repair, rebuild, respace, replace, operate and patrol electric transmission, distribution and communication lines consisting of suitable and sufficient poles and/or towers, with sufficient foundations, together with wires strung upon and extending between the same for the transmission and distribution of electric energy, together with all necessary fixtures, anchors, guys, braces, cables, wires and other electrical equipment and appurtenances, along and across said strip of land; also the right and easement at any and all times to cut down, trim and remove all trees, timber and bushes growing on said strip and to cut down, trim and remove such trees growing outside the limits of said strip as in falling would in the judgment of Central Maine Power Company, its successors and assigns, interfere with or endanger the operation and maintenance of the lines constructed along said strip; said strip being bounded on the north by a line parallel with and 75 feet distant northerly from the center line of the transmission line of Central Maine Power Company as now constructed along said strip, on the east by land of the Cushman Heirs, on the south by a line parallel with and 75 feet distant southerly from said center line, and on the west by land of the Buck estate.

**RESOLVE, in Favor of the Town of Palermo.**

Town of Palermo; money reallocated. Resolved: That the money appropriated in favor of the town of Palermo by the 92nd legislature for the repairing of the road beginning at state aid road and extending over Level Hill, so called, to state aid road at North Palermo be, and hereby is,

reallocated to be expended during the fiscal year ending June 30, 1948 on repairing the road beginning at state aid road, No. 3, and extending through the valley to state aid road No. 2.

## Chapter 56

**RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Washington County to Ernest Stover of Lambert Lake.**

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Ernest Stover, of Lambert Lake, whatever interest the state has in 2.50 acres more or less, being a part of the 99 acre tract which is described as follows: Tract in N. E. part of T. 1, R. 3, T. S. Washington county, of 5 parcels. (1) described in deed dated March 12, 1921, recorded in Washington registry of deeds, book 342, page 390. (2) described in deed dated March 7, 1924, recorded in said registry, book 365, page 10. (3) described in deed dated April 18, 1925, recorded in said registry, book 358, page 412. (4) described in deed dated July 30, 1926, recorded in said registry book 372, page 362. (5) described in deed dated January 19, 1927, recorded in said registry, book 376, page 74. With buildings. The sum due on the 2.50 acre tract is \$110.75.
