Chapter 62

RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Land in Piscataquis County to Bradbury Memorial Hospital, of Belfast.

State tax assessor authorized to convey certain lands. **Resolved:** That the state tax assessor be, and hereby is, authorized to convey to Bradbury Memorial Hospital, of Belfast, whatever interest the state has in an undivided $\frac{1}{2}$ of 744/2041 of 10,205 acre tract in T. 1, R. 14, W. E. L. S., Piscataquis county, containing 1,860 acres, more or less, for the sum of \$819.90.
