## Chapter 112

**RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Somerset County to C. Max Hilton, of Greenville.**

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to C. Max Hilton, of Greenville, whatever interest the state has in  $33/560$  undivided of 21,890 acres in T. 4, R. 3, N. B. K. P. Somerset county and in  $33/840$  undivided of 21,890 acres in T. 4, R. 3, N. B. K. P. Somerset county. The 21,890 acre tract is described as follows: All according to survey and plan of said township made and returned to the State Land Office by John Neal, et als in 1811-12, with exception of 2 farms containing 50 and 100 acres, exclusive of Public Lot, containing 21,890 acres, more or less. The sum due on these fractional interests is \$1,647.85.

## Chapter 113

**RESOLVE, Authorizing Maine State Park Commission to Lease Mount Blue State Park to Town of Weld.**

Mount Blue State Park, leased to town of Weld. Resolved: That the Maine state park commission be, and hereby is, authorized to sub-lease to the town of Weld, in the county of Franklin, the area known as the Mount Blue State Park, if approval of federal government is obtained.

## Chapter 114

**RESOLVE, Authorizing the State Tax Assessor to Convey by Sale Certain Interest of the State in Lands in the Unorganized Territory and in the City of Bangor.**

State tax assessor is authorized to convey lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey by sale certain interest of the state in lands in unorganized territory and in the city of Bangor, such sale of the following described parcels of property to be made to the highest bidder, provided

1. that notice of such sale be published 3 times, once each week for 3 consecutive weeks in some newspaper in the county where such lands lie;
