Chapter 141

RESOLVE, in Favor of Washington County.

Washington county; reimbursed. Resolved: That there be, and hereby is, appropriated the sum of \$1,094.53 from the general highway fund to be paid to the county of Washington to reimburse said county for money expended by it for snow removal in excess of \$35 per mile.

Effective August 13, 1947

Chapter 142

RESOLVE, in Favor of Joseph V. Tardiff, of Augusta.

Joseph V. Tardiff; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$750 to be paid to Joseph V. Tardiff, of Augusta, to compensate him in full for all claims against the state for injuries sustained by him during his employment with the state department of health and welfare; said sum to be paid from the health and welfare fund.

Chapter 143

RESOLVE, in Favor of the Town of Leeds.

Town of Leeds; money reallocated. Resolved: That the money appropriated in favor of the town of Leeds by the 91st legislature to paint the bridge which spans Dead river, known as the Stinchfield bridge, be, and hereby is, reallocated to be expended in the ensuing fiscal years to aid in repairing or tarring the road beginning at Gould's corner on state aid #5, and extending southerly on west side of Boothby hill to state aid #1.

Effective August 13, 1947

Chapter 144

RESOLVE, in Favor of the Town of Warren.

Town of Warren; money reallocated. Resolved: That the money appropriated in favor of the town of Warren by the 92nd legislature to aid in repairing the old #1, so called, in said town of Warren, a distance of ap-

proximately .6 of a mile, be and hereby is, reallocated to be expended in the ensuing fiscal years to aid in repairing the road leading from route #1 to the Warren depot.

RESOLVE, in Favor of a Bridge Across the West Branch of the Penobscot River, in Indian Purchase 3, Penobscot County.

Bridge over West Branch of Penobscot River; appropriation for. Resolved: That there be, and hereby is, appropriated from the general highway fund the sum of \$125,000 for the purpose of constructing a bridge across the West Branch of the Penobscot river in Penobscot county, on the state highway which leads from Brownville, in the county of Piscataquis, to Millinocket, in the county of Penobscot.

Chapter 146

RESOLVE, Appropriating Money to Improve the Approach to the Fish Way at Aroostook Falls.

Fish way at Aroostook Falls; improving the approach of. Resolved: That there be, and hereby is, appropriated the sum of \$3,000 to be taken from the general fund of the state and expended by and at the discretion of the commissioner of inland fisheries and game, if and when the money is available, for improving the approach to the fish way at Aroostook Falls on the Aroostook river in the Province of New Brunswick.

Any and all acts done in compliance with the provisions of this resolve in the Province of New Brunswick shall be with the consent and approval of said Province.

RESOLVE, in Favor of the University of Maine for Operations and Maintenance of the Brunswick Campus.
