#### Chapter 186

AN ACT Relating to Salaries and Clerk Hire for Certain Public Offices in Piscataquis County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 114, amended. The 12th paragraph of section 114 of chapter 79 of the revised statutes is hereby amended to read as follows:

'Piscataquis, \$1,600 \$1,800,'

Sec. 2. R. S., c. 79, § 146, amended. The 12th paragraph of section 146 of chapter 79 of the revised statutes is hereby amended to read as follows:

'Piscataquis, \$500 \$600,'

Sec. 3. R. S., c. 79, § 165, amended. The 12th paragraph of section 165 of chapter 79 of the revised statutes is hereby amended to read as follows:

'Piscataquis, \$1,400 \$1,600,'

Sec. 4. R. S., c. 79, § 269, amended. The 12th paragraph of section 269 of chapter 79 of the revised statutes, as amended by chapter 38 of the public laws of 1945, is hereby further amended to read as follows:

'Piscataquis county: for clerks in the office of the register of deeds, \$7,300 \$1,456; for clerks in the office of register of probate, \$650 \$728; for clerks in the office of clerk of courts, \$7,300 \$1,456.'

#### Chapter 187

AN ACT Relating to Salary of Register of Deeds and Clerks in the Office of Register of Deeds, Northern Registry, Aroostook County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of register of deeds in Aroostook county, northern registry, as amended by section 5 of chapter 157 of the public laws of 1947, is hereby further amended to read as follows:

'Aroostook, northern registry, \$1,500 \$2,200;'
