violation of the provisions of this chapter, and that the claimant is entitled to the custody of any part thereof, he shall give him an order in writing, directed to the officer having the same in custody commanding him to deliver to said claimant the articles, or proceeds derived from the sale of the same, to which he is so found to be entitled, within 48 hours after demand. If the magistrate finds the claimant entitled to no part of said articles so seized, he shall render judgment against him for the libelant for costs, to be taxed as in civil cases before such magistrate, and issue execution thereon, and shall declare said articles forfeited to the state. The claimant may appeal and shall recognize with sureties as on appeals in civil causes from a magistrate.'

Chapter 416

AN ACT Relating to Aid to Dependent Children.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 22, § 234, amended. Section 234 of chapter 22 of the revised statutes is hereby amended to read as follows:

'Sec. 234. Towns to be assessed. The Effective as of October 1, 1949, the state shall recover from the city, town or plantation in which the child so aided has legal settlement, $\frac{1}{2}$ 18% of the amount expended for aid to each dependent child, which shall be credited to the regular legislative appropriation for aid to dependent children; provided, however, that in the event that the federal allowance for aid to each dependent child should be increased subsequent to July 24, 1937, the reimbursement to the state by the city, town, or plantation shall be decreased accordingly. Whenever it appears that a city, town or plantation is delinquent in making reimbursements to the state, the amounts shall be collected by the state in the same manner and subject to the same penalties as state taxes. Any balance due shall be assessed in the succeeding year in the same manner as other state taxes.'

AN ACT Relative to Licensing Dealers in Livestock.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 27, §§ 123-A - 123-H, additional. Chapter 27 of the revised statutes is hereby amended by adding thereto 8 new sections to be numbered 123-A to 123-H, inclusive, to read as follows:
