The said corporation shall never make any division or dividend of or from its property or income among its members.'

Chapter 34

AN ACT Authorizing Prepayments by the County Treasurer of Somerset County to the Law Library Association for the Purchase of Law Books.

Be it enacted by the People of the State of Maine, as follows:

Prepayments to county law library association authorized. The treasurer of the county of Somerset is hereby directed to pay to the treasurer of the law library association of Somerset county such sum or sums, not to exceed \$3,000 in the aggregate, as may be requested by the treasurer of said association and approved by the county commissioners of said county, for the purchase of law books for said association. The sums so paid shall constitute advance, partial prepayments on the annual payments to said association directed to be made by section 151 of chapter 79 of the revised statutes as amended, becoming payable after the effective date of this act.

A sum equal to 10% of the total amount of such prepayments theretofore made shall be charged to and deducted from the annual payment for the 1st year subsequent thereto, and a similar deduction of 10% of the total amount theretofore advanced shall be made from the annual payment for each and every year thereafter until such deductions from the annual payments shall have equalled the total sum advanced to the treasurer of said association as prepayments under authority of this act.

No obligation is hereby imposed upon the county commissioners of Somerset county to approve requested prepayments.

Chapter 35

AN ACT Relating to the Federal Employees' Credit Union of Maine.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1931, c. 11, § 3, amended. Section 3 of chapter 11 of the private and special laws of 1931, as amended by chapter 12 of the private and special laws of 1939, is hereby further amended to read as follows:

'Sec. 3. Shareholders and capital stock. The capital stock shall be ~~\$150,000~~ unlimited. No person, unless employed by the federal government, shall become or continue to be a shareholder and the by-laws of the corporation shall, subject to the approval of the bank commissioner, contain provisions to carry into effect this section. Shares of capital stock may be subscribed and paid for in such manner as the by-laws may prescribe except that the par value of shares shall not exceed \$5. No person shall own more than 500 shares.'

Chapter 36

AN ACT Appropriating Moneys for State General Relief.

Emergency preamble. Whereas, because of the increase in the cost of living, and

Whereas, an increase in the number of unemployed persons have forced a larger number of persons to seek relief from the poor departments of the various municipalities, and

Whereas, it is necessary to reimburse such municipalities for such increased relief expenditures during the current fiscal year, and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of the constitution of Maine, and require the following legislation as immediately necessary for the preservation of public peace, health and safety, now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Appropriation. There is hereby appropriated out of any moneys in the general fund not otherwise appropriated the sum of \$165,000 for the fiscal year ending June 30, 1949 for state general relief.

Emergency clause. In view of the emergency cited in the preamble, this act for all purposes shall take effect when approved.

Chapter 37

AN ACT Relating to Retirement Pensions for Police and Fire Departments of the City of Portland.

Be it enacted by the People of the State of Maine, as follows:
