trustees thereof are hereby authorized and empowered to give, grant, convey, transfer, assign and set over to the inhabitants of the city of Brewer, a body corporate, its successors and assigns, the cemetery and all lands and their appurtenances on North Main street in the city of Brewer and all other grounds owned by said association and trustees by appropriate deed of the fee thereof, subject to such rights of occupation and burial as have heretofore been granted by said association, and also all trust funds held by said association and trustees.

Sec. 3. Inhabitants of city of Brewer authorized to accept and hold cemetery and trust funds. The inhabitants of the city of Brewer are hereby authorized and empowered to accept the cemetery, lands and their appurtenances on North Main street in said city of Brewer and all other grounds owned by the Woodlawn Memorial Cemetery Association of Brewer and the trustees thereof, and also all trust funds held by said association and trustees, and to hold, conduct, manage, maintain and administer said property and trust funds according to the laws of the state of Maine in such cases made and provided.

Sec. 4. Transfer of general funds. After such transfer and after settlement of its liabilities and accounts, Woodlawn Memorial Cemetery Association of Brewer may deliver over to the inhabitants of the city of Brewer such amounts as may remain of its general funds, the same to be accepted and used by the inhabitants of the city of Brewer as part of the general funds available for maintenance and upkeep of the cemetery.

Chapter 97

AN ACT to Provide Civil Service Rights to the Chief of Police and the Fire Chief of the City of South Portland.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1933, c. 55, Art. 8, § 1, sub-§ b, amended. Subsection b of section 1 of article 8 of chapter 55 of the private and special laws of 1933 is hereby amended to read as follows:

'b. The following officers and boards shall be appointed by the city manager, subject to confirmation by the city council:

1. Commissioner of public works
2. Chief of police and fire departments
3. 2. Chief clerk of board of assessors
4. 3. Bookkeeper
5. 4. Superintendent of poor department
6. 5. Corporation counsel
7. 6. Health officers and city physician
8. 7. Building inspector
9. 8. Plumbing inspector
10. 9. City chaplain
11. 10. Milk inspector
12. 11. City electrician

13. 12. All other department heads now existing, or which may be appointed, established through ordinance or resolve, and except as hereafter provided, these various department heads may hire their own subordinate clerks and employees as needed, subject to the approval of the city manager as to number, but not subject to his approval as to personnel.'

Sec. 2. P. & S. L., 1933, c. 55, Art. 8, § 3, amended. Section 3 of article 8 of chapter 55 of the private and special laws of 1933, as amended by section 10 of chapter 89 of the private and special laws of 1933, is hereby further amended to read as follows:

'Sec. 3. Civil service rules for police and fire departments. The city council shall provide by ordinance for a system of civil service rules for the appointment, promotion, demotion, lay off, reinstatement, suspension and removal of the members of the police department and of the fire department, ~~other than~~ including the chiefs of said departments, and for a civil service commission to administer the same. No further or other physical examination shall be required of the present members of the police or fire departments, including the chiefs of said departments, other than that to which they are now subject.'
