## Chapter 158

### AN ACT Providing for Bridges and Culverts on Certain Roads.

*Be it enacted by the People of the State of Maine, as follows:*

Construction and repair of bridges and culverts on certain roads. The state highway commission is hereby authorized and directed to expend the sum of \$5,000 annually for the construction and repair of bridges and culverts on the unimproved portion of the Baxter State Park road, so called, from Millinocket lake to Sourdnahunk field, and the Roaring Brook road, so called, which leads from the Togue Pond Forks to Roaring brook. Those portions, however, for which state aid may be available are excepted from the provisions of this act.

## Chapter 159

### AN ACT Relating to the Caribou Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1.** P. & S. L., 1905, c. 352, amended. The 3rd sentence of the 3rd paragraph of that part designated "Sec. 1." of chapter 57 of the private and special laws of 1945, which amended chapter 352 of the private and special laws of 1905, is hereby amended to read as follows:

'His salary shall be ~~\$7,000~~ \$1,250 a year, to be paid monthly from the treasury of the county of Aroostook.'

**Sec. 2.** P. & S. L., 1905, c. 352, amended. The 4th sentence of the 3rd paragraph of that part designated "Sec. 1." of chapter 57 of the private and special laws of 1945, which amended chapter 352 of the private and special laws of 1905, is hereby amended to read as follows:

'His duties shall include such duties as are performed by clerks of the superior court, so far as applicable and he shall draft all criminal warrants.'

Effective August 6, 1949
