## Chapter 208

### AN ACT to Make Allocations from the General Highway Fund for the Fiscal Years Ending June 30, 1950, and June 30, 1951.

**Emergency preamble.** Whereas, acts and resolves passed by the legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the said 90-day period will not terminate until after the beginning of the next fiscal year; and

Whereas, certain obligations and expenses incident to the operation of the state highway commission will become due and payable on or immediately after July 1, 1949; and

Whereas, in the judgment of the legislature, these facts create an emergency within the meaning of the constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Allocation of general highway fund.** Income to the general highway fund for the next 2 fiscal years—from July 1, 1949 to June 30, 1950 and from July 1, 1950 to June 30, 1951—shall be segregated, apportioned and expended as designated in the following schedules:

H The state highway commission may enter into agreements with the Public Roads Administration of the Federal Works Agency to provide for obligating \$3,600,000 of general highway funds to be collected during the fiscal year ending June 30, 1952, for matching federal aid apportioned to the state of Maine under the Federal Aid Highway Act of 1948.

The State Highway Commission may expend state and/or Federal funds not exceeding \$200,000 for maintenance and repairs of the Vaughan Bridge in Cumberland County between Portland and South Portland.

**Sec. 2. Allocation of the unappropriated general highway fund surplus.** The unappropriated general highway fund surplus, with the approval of the governor and council, may be apportioned by the state highway commission for the following purposes:

1. For payment of such cost as may be necessary for bond interest and retirement in addition to the amounts hereinbefore allocated.
2. For matching federal funds.
3. For maintenance of state and state aid highways.
4. For construction of bridges on state, state aid and third class highways under the provisions of sections 82 to 92, inclusive, of chapter 20 of the revised statutes.
5. For extra administration costs not anticipated in the budget of any department or agency receiving allocations from the general highway fund.

**Emergency clause.** In view of the emergency cited in the preamble, this act shall take effect when approved.

## Chapter 209

AN ACT Amending the Charter of the City of Lewiston.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. P. & S. L., 1939, c. 8, Art. V, § 9, amended.** Section 9 of Article V of chapter 8 of the private and special laws of 1939, as amended by chapter 16 of the private and special laws of 1945, is hereby further amended to read as follows:
