RESOLVES

lot No. 46 in the south division of Houlton and particularly described as follows: Beginning at a point in the northwesterly side line of the Military road, which point is so situated that a line drawn northwesterly thereupon at right angles with said Military road side line will be 65 feet northeasterly from the northeasterly sill of the large barn of the set of farm buildings owned and occupied by Beatrice M. McLaughlin; thence at right angles with said Military road side line, northwesterly 537.77 feet to a point; thence at right angles northeasterly, 405 feet to a point; thence at right angles, southeasterly 537.77 feet to a point in the northwesterly side line of said Military road; thence southwesterly by said side line, 405 feet to the point of beginning, containing approximately five acres. Also, the right to construct a drain from the northwesterly boundary of the above described parcel of land, across land of Beatrice M. McLaughlin to the Meduxnekeag River, the location of said drain to be determined by the grantee, and when said drain is constructed its location shall thereby become fixed and limited with the right, forever, to the grantee, its successors and assigns to enter on said location to repair, maintain and renew said drain; being the premises conveyed to the inhabitants of the town of Houlton by Beatrice M. McLaughlin by her deed dated March 22, 1941 and recorded in the Aroostook Registry of Deeds, Vol. 496, Page 460. Reference for an exact description of the premises is made to a plan entitled Armory Site, Military road, Houlton, Me., Plan "B" dated Feb. 20, 1941 which is on file in said Registry in Plan Book 11, Page 72.

Chapter 46

RESOLVE, Relating to Impounded Bank Accounts of Certain Trust Funds.

Impounded bank accounts of certain trust funds, charged off. Resolved: That the treasurer of state and the state controller be, and hereby are, authorized to charge off the records of the state the sum of \$493.97, representing losses on impounded bank accounts of certain trust funds, against which losses there has been set up a reserve in the amount of \$493.97. The trust funds and their respective amounts are as follows:

Resolved: That there be, and hereby is, appropriated from the unappropriated surplus of the general fund the sum of \$2,000 to restore the original principal of the trust fund known as the Colonel Black Fund of the Augusta State Hospital.

Chapter 47

RESOLVE Authorizing the State Tax Assessor to Convey by Sale Certain Interest of the State in Lands in the Unorganized Territory.

State tax assessor is authorized to convey lands. **Resolved:** That the state tax assessor be, and hereby is, authorized to convey by sale certain interest of the state in lands in unorganized territory, such sale of the following described parcels of property to be made to the highest bidder, provided

1. that notice of such sale be published 3 times, once each week for 3 consecutive weeks in some newspaper in the county where such lands lie;
2. that no parcel shall be sold for less than the amount as recommended below except in those cases in which sale is to be made to a specific individual or individuals as also recommended, in which case no notice shall be published.

In the event bids in the minimum amount as recommended below are not received after notice, the state tax assessor may thereafter sell for not less than the minimum amount, without again asking for bids; provided that such property is sold on or before November 1, 1950.
