Private and Special Laws

OF THE

STATE OF MAINE

As Passed by the Ninety-fifth Legislature

1951

'Sec. 2. Powers. Said corporation is authorized to manufacture in Lewiston, Maine, cotton, wool, and flax in the city of Lewiston, rayon, nylon and any other natural, artificial and synthetic fibres and materials and any combination, blend or mixture of any of them, textile fabrics, cloth, and any products which may be derived by or in the course of such manufacture; to buy, sell and otherwise deal in textile fabrics and cloth, and natural, artificial and synthetic fibres and materials, and any products which may be derived by or in the course of manufacturing as above authorized; to purchase, and hold and have any real and personal estate ~~not exceeding in value fifteen hundred thousand dollars~~ necessary or convenient for its business; to build and erect or otherwise acquire such buildings and machinery as ~~their~~ the convenience of its business may require, and make ~~all such necessary~~ by-laws, rules and regulations for the prosecution of the same as may be consistent with the laws of the state of Maine.'

Chapter 35

AN ACT to Extend the Charter of the Eliot Water District.

Be it enacted by the People of the State of Maine, as follows:

Extension of powers. The rights, powers and privileges granted by chapter 101 of the private and special laws of 1941 and the extending of such rights, powers and privileges granted by chapter 152 of the private and special laws of 1947 are hereby extended for a term of 4 years from the effective date of this act, and all acts performed under the provisions of such chapters are hereby validated and declared to be legal acts of the district.

Chapter 36

AN ACT to Extend the Rights, Powers and Privileges of the Penobscot Valley Water Commission.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1947, c. 166, extended. The rights, powers and privileges of the Penobscot Valley Water Commission which were granted by chapter

166 of the private and special laws of 1947, as amended by chapter 63 of the private and special laws of 1949, are hereby extended for and during a period of 2 years from August 13, 1951, and all the rights, powers and privileges that were granted by said chapter, as amended, may and shall be exercised in the same manner and for the same purposes as provided in said chapter, as amended.

Chapter 37

AN ACT to Amend the Charter of the City of Ellsworth School District.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1949, c. 9, § 1, amended. Section 1 of chapter 9 of the private and special laws of 1949 is hereby amended to read as follows:

'Sec. 1. Incorporation; name; purposes. Subject to the provisions of sections 7 and 9 hereof, the inhabitants of and the territory within the city of Ellsworth are hereby created a body politic and corporate under the name of "City of Ellsworth School District" for the purpose of acquiring property within the said city for school and related athletic and recreational purposes; for the purpose of erecting, enlarging, repairing, equipping and maintaining on said property a school building or school buildings for high school purposes and related athletic and recreational facilities; ~~for the purpose of completing, grading, furnishing, rebuilding, renovating and otherwise bettering the condition of any or all buildings within said city used for school purposes or which may hereafter be used for school purposes;~~ for the purpose of leasing or letting any property of said district to said city; for the purpose of receiving, accepting and holding gifts, grants or devises of property real, personal or mixed to be used for school and related athletic and recreational purposes; all for the benefit of the inhabitants of said city.'

Be it enacted by the People of the State of Maine, as follows:
