## Chapter 178

AN ACT to Amend the Charter of the Western Somerset Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1909, c. 331, § 5, amended. Section 5 of chapter 331 of the private and special laws of 1909 is hereby amended to read as follows:

'Sec. 5. Where regular terms shall be held. Regular terms of said court for the transaction of civil business shall be held as follows:

At Skowhegan, on the 1st Monday of every month excepting August, at 10 o'clock in the forenoon.

At Fairfield, on the 2nd Monday of January, March, May, July, September and November, at ~~nine~~ 10 o'clock in the forenoon.

At Madison, on the last Monday of every month excepting July, at ~~nine-thirty~~ 10 o'clock in the forenoon.

At Bingham, on the 2nd Monday of February, April, June, October and December, at ~~eleven~~ 10 o'clock in the forenoon.

Provided, however, that no writ or process which is dated before the effective date of this act, but made returnable after the effective date of this act, shall be dismissed because the hour on the return date is erroneous.'

## Chapter 179

AN ACT to Authorize the Building of a Private Road Across Massacre Pond, in Scarboro.

*Be it enacted by the People of the State of Maine, as follows:*

Gladys I. Jordan authorized to build private road. Gladys I. Jordan, of Scarboro, in the county of Cumberland and state of Maine, her heirs and assigns, are hereby authorized and empowered to build and maintain a private road across Massacre pond, so called, a great pond, situated in Scarboro, in the county of Cumberland, said private road to extend from land owned by said Gladys I. Jordan on the northwesterly side of said Massacre pond to land owned by her in common with another on the south-

easterly side of said Massacre pond; provided that a bridge be constructed in said road at least 8 feet in length and of sufficient height to permit the free passage of rowboats, canoes and their occupants under said bridge.

## Chapter 180

**AN ACT** Relating to the Salary of the Judge of the Northern Aroostook Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1947, c. 38, § 1, amended. The 3rd sentence of the 2nd paragraph of section 1 of chapter 38 of the private and special laws of 1947 is hereby amended to read as follows:

'His salary shall be ~~\$1,800~~ \$2,100 a year, to be paid monthly from the treasury of the county of Aroostook.'

## Chapter 181

**AN ACT** to Increase the Salary of the Judge of the Van Buren Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1947, c. 54, § 1, amended. The last sentence of the 2nd paragraph of section 1 of chapter 54 of the private and special laws of 1947 is hereby amended to read as follows:

'His salary shall be ~~\$1,800~~ \$2,100 a year, to be paid monthly from the treasury of the county of Aroostook.'
