Chapter 2

RESOLVE, Authorizing Commissioner of Inland Fisheries and Game to Convey Certain Land in Eastbrook to Edgar S. Gordon.

Commissioner of inland fisheries and game, in name of state of Maine, authorized to convey certain land. Resolved: That the commissioner of inland fisheries and game, in the name of the state of Maine be, and hereby is, authorized and directed to execute and convey by quitclaim deed to Edgar S. Gordon, of Eastbrook, in the county of Hancock and state of Maine, the interest of the state in a certain lot or parcel of land situated in the town of Eastbrook and bounded and described as follows:

Beginning at the southeast corner of the land now of said Edgar S. Gordon where it corners on the west side of the Macomber Mill road, so-called; thence north $84^{\circ} 22'$ west along the boundary line of the grantee and land formerly of Stanley U. Gordon, now of the state of Maine, 22.50 chains to a stake; thence south $5^{\circ} 20'$ west 9.00 chains to a stake; thence south $84^{\circ} 40'$ east 23.62 chains to a stake on the west side of the aforesaid road; thence north 10° east 4.89 chains and north $7^{\circ} 15'$ west 4.38 chains along the west side of said road to point of beginning. Containing 21.54 acres, more or less.

The above being a part of the land deeded to the state of Maine by Stanley U. Gordon by deed recorded in the Hancock county registry of deeds, book 733, page 75.

This area is also included in the condemnation proceedings filed by the department of inland fisheries and game on April 20, 1949 and recorded in the above stated registry, book 726, page 431.

Chapter 3

RESOLVE, Closing Limestone Stream to Fishing.

Limestone stream closed to fishing. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation to close Limestone stream, otherwise known as Little river, to fishing from the municipal swimming pool dam southerly down stream for a distance of approximately 2,000 feet to a point due north of the Bangor and Aroostook railway passenger station.
