Chapter 147

RESOLVE, Providing for State Pension for Florence I. Cain, of Clinton.

Florence I. Cain; state pension. Resolved: That a pension of \$40 per month be, and hereby is, granted to Florence I. Cain, of Clinton, to be paid monthly from the funds of the Maine State Retirement System. Such pension shall begin on July 1, 1951 and continue until otherwise provided by the legislature.

Effective August 20, 1951

Chapter 148

RESOLVE, Providing for a Pension for George M. D. Grant of Milbridge.

George M. D. Grant; pension for. Resolved: That a pension of \$1,200 per year be, and hereby is, granted to George M. D. Grant of Milbridge, Maine, to be paid monthly from the funds of the Maine State Retirement System to increase the pension he is now receiving under the provisions of chapter 60 of the revised statutes. Such pension shall begin on July 1, 1951 and continue until otherwise provided by the legislature.

Effective August 20, 1951

Chapter 149

RESOLVE, in Favor of Florence Goodwin, of Clinton.

Florence Goodwin; accumulated contributions refunded. Resolved: That the sum of \$61.80 is hereby appropriated to be paid from the general fund to Florence Goodwin, of Clinton, said sum being the amount she contributed to the retirement fund, plus interest, prior to her retirement.

Effective August 20, 1951

Chapter 150

RESOLVE, in Favor of Christian M. Jensen of Westbrook.

World War I bonus of Christian M. Jensen. Resolved: That there be, and hereby is, appropriated the sum of \$100 to be paid to Christian M. Jen-

sen, of Westbrook, as the World War I bonus due him; said sum to be paid from the general fund of the state.

Effective August 20, 1951

Chapter 151

RESOLVE, in Favor of Oscar Pinette, of Portland.

World War I bonus granted to Oscar Pinette. Resolved: That there be, and hereby is, appropriated \$100 to be paid to Oscar Pinette, of Portland, as his World War I bonus; said sum to be paid from the general fund of the state.

Effective August 20, 1951

Chapter 152

RESOLVE, in Favor of Jackman Plantation.

Jackman plantation; reimbursed. Resolved: That there be, and hereby is, appropriated the sum of \$144 to be paid to Jackman plantation to reimburse said plantation for the 1948 poll taxes in Rockwood, an unorganized territory, the electors of which were provided voting privileges by said plantation; said sum to be paid from the general fund of the state.

Effective August 20, 1951

Chapter 153

RESOLVE, in Favor of the Town of Warren.

Town of Warren; appropriation for. Resolved: That there be, and hereby is, appropriated the sum of \$976.09 from the general fund of the state to be paid to the town of Warren in payment of various bills owed for fire fighting at the State Prison Farm.

Effective August 20, 1951
