RESOLVES, 1951**CHAP. 160**

Freeport Grain Company, of Freeport, as a full and final settlement of its claim against the state for damage to grain and other stock by an escapee from the Pownal state school.

Effective August 20, 1951

Chapter 158

RESOLVE, in Favor of W. I. Hamilton, of Bath.

W. I. Hamilton; reimbursed. Resolved: That the sum of \$60.17 be, and hereby is, appropriated to be paid to W. I. Hamilton, of Bath, for taxes assessed and paid by Mr. Hamilton from 1942 to 1948 on land in unorganized territory in Big W, N.B.K.P., Somerset county, not owned by him; said sum to be paid from the general fund.

Effective August 20, 1951

Chapter 159

RESOLVE, in Favor of Carrie M. Longfellow, of Machias.

Carrie M. Longfellow; refund. Resolved: That Carrie M. Longfellow, of Machias be paid the sum of \$1,185.17 which represents the amount contributed by her to the teachers' saving fund during the school years 1931 through 1945; said sum to be paid from the funds of the Maine state retirement system.

Chapter 160

RESOLVE, Providing for State Pension for Mrs. Minnie Fenderson, of Saco.

Teacher's pension granted to Mrs. Minnie Fenderson, of Saco. Resolved: That a special pension be, and hereby is, granted to Mrs. Minnie Fenderson, of Saco, comparable with that paid under the teachers' noncontributory

pension law, based on 25 years of teaching service, as is now or may hereafter be provided by the legislature, to be paid quarterly from the appropriation for pensions for retired teachers. Such pension shall begin on July 1, 1951 and continue until otherwise provided by the legislature.

Chapter 161

RESOLVE, Granting a Pension to James E. Harvey, of Readfield.

James E. Harvey; pension for. Resolved: That James E. Harvey, of Readfield, be granted a retirement benefit comparable to that allowed a member of the Maine State Retirement System having at least 13 years of "prior service" and a total of at least 20 years service at age 70 or thereafter, to be paid from the funds of the said Maine State Retirement System. No part of this retirement benefit shall be payable unless the said James E. Harvey shall contribute to the Maine State Retirement System the sum of \$448.53.

Effective August 20, 1951

Chapter 162

RESOLVE, in Favor of Winifred Malloy, of Hallowell.

Winifred Malloy; retirement benefit granted. Resolved: That there be, and hereby is, granted to Winifred Malloy, of Hallowell, a retirement benefit in the sum of \$347.52, to be paid from the funds of the Maine State Retirement System.

Chapter 163

RESOLVE in Favor of Helen G. McShea, of Fort Fairfield.

Helen G. McShea; state pension increased. Resolved: That Helen G. McShea, of Fort Fairfield, be granted an annual pension of \$900, to be paid monthly; provided, however, that, as she is now receiving a state
