Chapter 174

RESOLVE, Appropriating Moneys for Moving Maine Vocational-Technical Institute.

Maine vocational-technical institute; appropriation for. Resolved: That there be, and hereby is, appropriated from the general fund the sum of \$90,000 for the fiscal year ending June 30, 1952 to move Maine vocational-technical institute from Augusta to Fort Preble, in South Portland, and to recondition the buildings at Fort Preble; and be it further

Resolved: That there be, and hereby is, appropriated from the general fund the sum of \$30,000 for the fiscal year ending June 30, 1952 for maintenance of Maine vocational-technical institute; and be it further

Resolved: That any unexpended balances shall not lapse but shall remain a continuing carrying account.

Chapter 175

RESOLVE, Providing Funds for Maintenance at Teachers' Colleges and Normal Schools.

Emergency preamble. Whereas, certain major repairs and maintenance at the 5 state teachers' colleges and normal schools are vitally necessary and should be completed immediately; and

Whereas, no other funds are available for this work; and

Whereas, such repairs and maintenance will restore the physical plants to a standard more compatible with their collegiate educational purpose; and

Whereas, such repairs and maintenance will result in more effective professional training programs for students enrolled; and

Whereas, if the work is done immediately, future heavier repairs will be prevented, resulting in greater savings to the people of Maine; and

Whereas, in the judgment of the legislature, these facts create an emergency within the meaning of the constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Funds for maintenance at teachers' colleges and normal schools. Resolved: That the sum of \$100,000 be, and hereby is, appropriated for the fiscal year ending June 30, 1951, and the sum of \$125,000 for the fiscal year ending June 30, 1952, to the department of education out of the current revenues of the general fund for deferred maintenance at the teachers' colleges and normal schools, to be expended at the several schools in the following amounts:

and be it further

Resolved: That the funds hereby appropriated shall not lapse but shall remain a continuing carrying account.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

Chapter 176

RESOLVE, Authorizing the Construction of a Road and Terminal in Rockland, Knox County.

Road and terminal; construction of. Resolved: That the state highway commission be, and hereby is, authorized and directed to reconstruct and extend Mechanic street from Main street in Rockland, Knox county, to Rockland harbor, and that the sum of \$2,900 be appropriated from the general highway fund for this purpose; and be it further

Resolved: That no work shall be commenced on the reconstruction and extension of Mechanic street until the funds for the construction of the wharf or terminal have been made available as hereinafter provided; and be it further
