Chapter 21.

AN ACT Relating to Clarification of Secondary School Tuition.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 37, § 98, amended. The 2nd paragraph of section 98 of chapter 37 of the revised statutes, as amended, is hereby further amended to read as follows:

'In the case of any youth attending school under conditions as provided for in the preceding paragraph, in schools in which the enrollment of tuition students is 10% or more of the total enrollment or attending any community high school, the annual tuition shall not exceed 115% of the average cost per pupil in all secondary schools of the state for the preceding fiscal year; except that, in a secondary school in which the enrollment of tuition pupils is less than 10% of the total enrollment or in which at least 3 courses of study, 2 of which are industrial or occupational, are not offered, the tuition shall not exceed the average cost per pupil in all secondary schools of the state for the preceding fiscal year.'

Sec. 2. R. S., c. 37, § 99, amended. The 2nd sentence of section 99 of chapter 37 of the revised statutes, as amended, is hereby further amended to read as follows:

'Tuition charges for each pupil may be paid by towns to an amount not exceeding the receiving school's average cost per pupil for the fiscal year preceding that for which the tuition is paid; except that payments in excess of said average cost may be made by vote of the sending town, but such payment by a town for any pupil for any one year shall be subject to the limitations of section 98.'

Chapter 22

AN ACT Relating to Clerks for Voting District in Town of Cranberry Isles.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 5, § 14, amended. The 2nd sentence of section 14 of chapter 5 of the revised statutes is hereby amended to read as follows:

'For each voting place in cities and towns, 4 clerks, and for each voting place in plantations and for each island ward of the city of Portland and for the island district of the town of Cumberland and the districts in the town of Cranberry Isles, 2 clerks shall be appointed.'

Chapter 23

AN ACT Repealing the School Building Assistance Commission.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 37, §§ 211-B - 211-J, repealed. Sections 211-B to 211-J, inclusive, of chapter 37 of the revised statutes, as enacted by chapter 437 of the public laws of 1949 and as amended, are hereby repealed.

Chapter 24

AN ACT Repealing Simpson's Pond Bird Sanctuary.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 128, amended. That part of section 128 of chapter 33 of the revised statutes, as revised, which relates to Simpson's Pond Bird Sanctuary, is hereby repealed.

AN ACT Relating to Inspection of Schools.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 37, § 3, sub-§ XII, amended. Subsection XII of section 3 of chapter 37 of the revised statutes, as amended, is hereby further amended to read as follows:
