Chapter 32

AN ACT Relating to Fees of Deputy Sheriffs.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 166, sub-§ XXXVIII, amended. Subsection XXXVIII of section 166 of chapter 79 of the revised statutes, as amended, is hereby further amended to read as follows:

'XXXVIII. Every deputy sheriff while performing special duties under order of the sheriff shall receive for such services §§ \$10 a day and such additional pay as the county commissioners may approve, together with necessary incidental expenses, to be paid from the county treasury, the bills for which shall be audited as provided in section 2 of chapter 137.'

Chapter 33

AN ACT Relating to Transportation of Fish from Moosehead Lake.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 49, amended. The last sentence of section 49 of chapter 33 of the revised statutes, as revised, is hereby amended to read as follows:

'Fish taken from ~~Moosehead lake~~ Rangeley lake, Mooselucmeguntic lake, Cupsuptic lake, Upper Richardson lake and Lower Richardson lake shall be limited to 1 shipment in any one calendar year.'

Chapter 34

AN ACT Relative to Moosehorn Game Preserve.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 33, § 128, amended. Section 128 of chapter 33 of the revised statutes, as revised, is hereby amended by adding thereto in alphabetical order a new paragraph to read as follows:

'Moosehorn Game Preserve: No person shall at any time hunt, pursue, molest, trap, catch, shoot at, kill or destroy any wild bird or wild animal within the right of way of the Maine Central Railroad from St. Croix Junction in Calais, southerly to the Charlotte town line.'

Chapter 35

AN ACT Repealing Law of Manufacture and Sale of Bedding and Upholstered Furniture.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 22, §§ 147-151-C, repealed. Sections 147 to 151, inclusive, as repealed and replaced by chapter 330 of the public laws of 1947; and sections 151-A to 151-C, inclusive, as enacted by chapter 330 of the public laws of 1947, of chapter 22 of the revised statutes, are hereby repealed.

Chapter 36

AN ACT Relating to Violations of Use Fuel and Motor Carrier Tax Laws.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 14, § 183-A, additional. Chapter 14 of the revised statutes, as amended, is hereby further amended by adding thereto a new section to be numbered 183-A, to read as follows:

'Sec. 183-A. Additional penalty. Any user, or any agent or employee of any user, who shall consume any fuel in a motor vehicle on a public highway or on a turnpike operated and maintained by the Maine Turnpike Authority, when such user is not the holder of an uncanceled license as required by sections 169 to 185, inclusive, or when such user has failed to file any report required by said sections, shall be punished by a fine of not less than \$10, nor more than \$300.'

Sec. 2. R. S., c. 14, § 185-G, amended. Section 185-G of chapter 14 of the revised statutes, as enacted by section 1 of chapter 362 of the public laws of 1947, and as renumbered by section 13 of chapter 349 of the public
