least 7 days before the date of examination, together with a deposit of \$25, which said deposit shall be returned to applicant in case the application is rejected. Each applicant must be at least 21 years of age, and shall present a diploma from a high school, academy, state normal school, college, or university proof of I year's satisfactory attendance at a college of liberal arts. On and after the calendar year 1957 candidates for licensure shall be required to present transcripts from an accredited college or university certifying that they have completed I year of pre-professional work, 2 subjects of which must be English and biology, or otherwise satisfy the members of the board of sufficient prior academic education. The applicant shall also present a diploma granted by a legally chartered chiropractic college, school, or university in good standing and having the power to confer degrees in chiropractic, which diploma shall show that it was granted on personal attendance of the applicant and completion of a course of 4 school years of not less than 8 months each, and of a total of 3,600 4,400 60-minute school hours. All applicants must also present a certificate of good moral character signed by some reputable resident of this state, and such other reasonable and proper facts as the board in its blank application may require.'

AN ACT Relating to Marking of Containers of Skim-Milk.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 27, § 109, repealed. Section 109 of chapter 27 of the revised statutes is hereby repealed.

Chapter 106

AN ACT Relating to Exhibits of Agricultural Fair Associations.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 27, § 17-A, amended. The 2nd sentence of section 17-A of chapter 27 of the revised statutes, as enacted by chapter 320 of the public laws of 1949, is hereby amended to read as follows:

CHAP. 108

'The total premium payments for these exhibits shall be, at least, an amount equal to the premiums or purses paid for pulling contests at this same fair and race meet, and not less than 35% of the amount paid for purses for harness horse races conducted during the annual fair.'

Chapter 107

AN ACT Relating to Delivery of Ballots by Absentee Voters.

Be it enacted by the People of the State of Maine, as follows:

- R. S., c. 6, § 8, repealed and replaced. Section 8 of chapter 6 of the revised statutes is hereby repealed and the following enacted in place thereof:
- 'Sec. 8. Receipt of ballots by absent voter. All ballots cast under the provisions of the preceding section whether delivered in person or by mail shall be received by the plantation, town or city clerk before the closing of the polls on the day of election.'

Chapter 108

AN ACT Relating to Leave of Absence Under the Military Law.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 12, § 80, amended. The 2nd paragraph of section 80 of chapter 12 of the revised statutes is hereby amended to read as follows:

'All officials and employees of this state who shall be members of the national guard or other authorized state military or naval forces thereof and military army, air force, marine, coast guard and naval reservists shall be entitled to leave of absence from their respective duties, without loss of pay or time, on all days during which they shall be engaged in field, naval, air, or coast defense training ordered or authorized by the governor or under the provisions of the national defense act or Armed Forces Reserve Act of 1952.'
