## Chapter 276

### AN ACT Increasing Salaries of County Officers of Somerset County.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., c. 79, § 6, amended. That part of section 6 of chapter 79 of the revised statutes which relates to the salary of the county commissioners of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$\$\$~~ \$1,000.'

Sec. 2. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to the salary of the clerk of courts of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$3,000~~ \$3,500.'

Sec. 3. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of the county attorney of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$1,800~~ \$2,500.'

Sec. 4. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to the salary of the county treasurer of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$1,200~~ \$1,600.'

Sec. 5. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to the salary of the sheriff of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$2,400~~ \$3,000.'

Sec. 6. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of the register of deeds

of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$2,300~~ \$2,900,'

Sec. 7. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to the salary of the judge of probate of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$2,300~~ \$3,000,'

Sec. 8. R. S., c. 140, § 22, amended. That part of section 22 of chapter 140 of the revised statutes which relates to the salary of the register of probate of Somerset county, as amended, is hereby further amended to read as follows:

'Somerset, ~~\$2,200~~ \$2,600,'
