AN ACT Relating to the Salary of the County Attorney of Aroostook County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of the county attorney of Aroostook county, as amended, is hereby further amended to read as follows:

'Aroostook, ~~\$2,500~~ \$3,000,'

Chapter 278

AN ACT Relating to Salaries of County Officers in Androscoggin County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 6, amended. That part of section 6 of chapter 79 of the revised statutes which relates to the salary of county commissioners

of Androscoggin county, as amended, is hereby further amended to read as follows :

'Androscoggin, ~~\$1,200~~ \$1,320, except the chairman of said commission who, in addition to his regular duties, shall superintend the county buildings, and for all his services his annual salary shall be the sum of ~~\$1,800~~ \$1,980.'

Sec. 2. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to the salary of clerk of courts of Androscoggin county, as amended, is hereby further amended to read as follows :

'Androscoggin, ~~\$3,000~~ \$3,300,'

Sec. 3. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of county attorney and assistant county attorney of Androscoggin county, as amended, is hereby further amended to read as follows :

'Androscoggin, ~~\$3,000~~ \$3,300; assistant county attorney, ~~\$2,200~~ \$2,420,'

Sec. 4. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to the salary of county treasurer of Androscoggin county, as amended, is hereby further amended to read as follows :

'Androscoggin, ~~\$2,500~~ \$2,750,'

Sec. 5. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to the salary of sheriff of Androscoggin county, as amended, is hereby further amended to read as follows :

'Androscoggin, ~~\$3,500~~ \$3,850,'

Sec. 6. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of register of deeds of Androscoggin county, as amended, is hereby further amended to read as follows :

'Androscoggin, ~~\$3,000~~ \$3,300,'

Sec. 7. R. S., c. 136, § 28, amended. The 3rd paragraph of section 28 of chapter 136 of the revised statutes, as amended, is hereby further amended to read as follows:

'The county of Androscoggin shall have 2 probation officers, one to be designated probation officer and one to be designated assistant probation officer; and the county commissioners for Androscoggin county shall pay the probation officer a salary of ~~\$3,000~~ \$3,300, annually, and shall pay the assistant probation officer a salary of ~~\$2,200~~ \$2,420, annually; and furthermore the probation officers for Androscoggin county shall be entitled to select a clerk or stenographer for the probation office, and the county commissioners shall appropriate the sum of ~~\$1,820~~ \$2,080, annually, for such clerk hire. Furthermore, the county commissioners for Androscoggin county shall provide suitable quarters in the county building for this office.'

Sec. 8. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to the salary of judge of probate of Androscoggin county, as amended, is hereby further amended to read as follows:

'Androscoggin, ~~\$3,000~~ \$3,300.'

AN ACT Relating to Divesting Property in Qualifications for Old Age Assistance and Aid to the Blind.

Sec. 1. R. S., c. 22, § 265, amended. The 1st paragraph of section 265 of chapter 22 of the revised statutes is hereby amended to read as follows:

'Any applicant for or recipient of old age assistance, who divests himself directly or indirectly of any property after January 1, 1950 without a
