Chapter 100

AN ACT Amending the Charter of the Maine School for the Deaf.

Be it enacted by the People of the State of Maine, as follows:

- P. & S. L., 1897, c. 446, § 2, amended. Section 2 of chapter 446 of the private and special laws of 1897 is hereby amended to read as follows:
- 'Sec. 2. Location; state may accept conveyance of lot and buildings. Said school shall be located at Portland in the county of Cumberland, and the governor and council are hereby authorized, on behalf of the state, to accept a conveyance from the city of Portland of the school lot, building and fixtures now used as a school for the deaf in said Portland upon the condition that the state shall hereafter assume the entire charge, responsibility and expense of maintaining said school.'

Chapter 101

AN ACT to Ratify and Confirm the Incorporation of Berwick Monthly Meeting of Friends.

Be it enacted by the People of the State of Maine, as follows:

Incorporation of Berwick Monthly Meeting of Friends ratified. The incorporation of Berwick Monthly Meeting of Friends, in the county of York, is hereby declared to be in existence and to have been in existence since its incorporation; and the register of deeds in and for the county of York is hereby authorized and instructed to enter upon his records this validation of the incorporation of Berwick Monthly Meeting of Friends in accordance with this act; and the secretary of state is hereby authorized and instructed to enter upon his records the charter of Berwick Monthly Meeting of Friends.

AN ACT to Increase the Salaries of the Judge and Recorder of the Northern Aroostook Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1911, c. 178, amended. The last sentence of the 2nd paragraph of that part designated "Sec. 1." of chapter 38 of the private and

special laws of 1947, which amended chapter 178 of the private and special laws of 1911, as amended by chapter 180 of the private and special laws of 1951, is hereby further amended to read as follows:

'His salary shall be \$2,100 \$2,400 a year, to be paid monthly from the treasury of the county of Aroostook.'

Sec. 2. P. & S. L., 1911, c. 178, amended. The 3rd sentence of the 3rd paragraph of that part designated "Sec. 1." of chapter 38 of the private and special laws of 1947, which amended chapter 178 of the private and special laws of 1911, is hereby amended to read as follows:

'His salary shall be \$400 \$700 a year to be paid monthly from the treasury of the county of Aroostook.'

Chapter 103

AN ACT to Increase the Salary of the Judge of the Van Buren Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1939, c. 18, amended. The last sentence of the 2nd paragraph of that part designated "Sec. 1." of chapter 54 of the private and special laws of 1947, which amended chapter 18 of the private and special laws of 1939, as amended by chapter 181 of the private and special laws of 1951, is hereby further amended to read as follows:

'His salary shall be \$2,100 \$2,400 a year, to be paid monthly from the treasury of the county of Aroostook.'

Chapter 104

AN ACT Relating to Salary of Judge and Fees Paid to Waterville Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1897, c. 325, § 3, amended. Section 3 of chapter 325 of the private and special laws of 1897, as amended by chapter 98 of
