RESOLVES, 1953

Trescott Township, Washington county

Lot in S. R., E. Division, bounded N. by Heirs of Raymond Denbow, Hazel O. Jones, S. by Cutler Road, W. by George Moores; according to Jones' plan, revised; with buildings, containing 12 acres, more or less.

Sell to Almon Farmer for \$94.54.

Trescott Township, Washington county

S. parts Lots 15 and 16, R. I, E.; bounded N. by Harry Gilpatrick and Raymond Hall; E. by Fred B. and James E. Jones; S. by own land; W. by Haycock's Harbor Road, with buildings (19 acres); part lot 54, E. of Haycock's Harbor Road (50 acres); part lot 6, R. 2, bounded N. by R. L. Owens; E. by Albert McLaughlin; S. by Lubec Road; W. by Charles McCarty (25 acres); all according to Jones Plan, revised, containing 94 acres, more or less.

Sell to Harmon Jones for \$145.31 and if he does not pay such amount within 60 days from effective date of this resolve, sell to highest bidder for not less than \$150.

Trescott Township, Washington county

Part Lots 35 and 43, R. 2, bounded N. by East Stream, E. by Lauren Pressley, A. R. Card, S. by A. R. Card, W. by McLellan Road, Lauren Pressley and H. E. Saunders; with buildings (50 acres); W. ½ Lot 42 and Lot 43, S. Range (110 acres), Jones' plan, revised, containing 169 acres, more or less. Excepting all but W. ½ Lots 42 and 43, 110 acres.

RESOLVE, Closing Sourdnahunk Lake, Piscataquis County, to All Fishing.

Sourdnahunk lake closed to fishing. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation to close Sourdnahunk lake, Township 4, Range

RESOLVES, 1953

CHAP. 32

Io to all fishing from August 15th to April 15th, inclusive, that part of the thoroughfare north of Sourdnahunk dam, so called, a distance of ½ mile, to a point designated by 2 red posts set on the shores of said thoroughfare.

Chapter 31

RESOLVE, in Favor of the Town of Friendship.

Town of Friendship; money reallocated. Resolved: That the sum of \$425 appropriated in favor of the town of Friendship, by the 95th legislature for the fiscal year ending June 30, 1952, for the replacing or repairing the present wooden Goose River bridge, so called, on route #220, between Waldoboro and Friendship, with a multi-plate culvert with necessary fill be, and hereby is, reappropriated to be expended to aid in repairing and tarring state aid road #9, known locally as Timber Point or Fisherman's road, for a distance of approximately 7/10 of a mile, running from route #220 and extending in a westerly direction to the shore of the Medomak river.

Chapter 32

RESOLVE, in Favor of the Town of Hudson.

Town of Hudson; reallocation of unexpended appropriation. Resolved: That the unexpended balance of \$1,000, remainder of the appropriation for the town of Hudson for the fiscal year ending June 30, 1953 to aid in repairing the Gerry road, so called, leading from route #43 to Alton town line, be, and hereby is, reallocated to the Long Swamp road, so called, state aid #2, leading from route #221 over Hudson Hill to the Corinth town line.
