Chapter 162

RESOLVE, in Favor of the Town of Aurora.

Town of Aurora; reimbursed. Resolved: That there be, and hereby is, appropriated the sum of \$337.38 from the general fund unappropriated surplus of the state to be paid to the town of Aurora to reimburse said town for fighting fire on Spruce Mountain, so called, in Aurora.

Effective August 8, 1953

Chapter 163

RESOLVE, in Favor of the City of Auburn.

City of Auburn; reimbursed. Resolved: That there be, and hereby is, appropriated the sum of \$1,768.82 from the general fund of the state to be paid to the city of Auburn to reimburse it for supplies to dependent persons furnished to the family of Otis Colson from April 1949 to January 1952.

Effective August 8, 1953

Chapter 164

RESOLVE, Providing for a Retirement Pension for Lydia B. Otis, of Carmel.

Lydia B. Otis; retirement pension. Resolved: That a pension of \$50 per month be, and hereby is, granted to Lydia B. Otis, of Carmel, to be paid monthly from the funds of the Maine state retirement system. Such pension shall begin on July 1, 1953 and continue until otherwise provided by the legislature.

Chapter 165

RESOLVE, in Favor of a Retirement Allowance for Gertrude E. Durost of Mars Hill.

Gertrude E. Durost; retirement allowance. Resolved: That a retirement allowance of \$37.69 per month be, and hereby is, granted to Gertrude

CHAP. 167**RESOLVES, 1953**

E. Durost of Mars Hill, to be paid monthly from the funds of the Maine state retirement system. Such retirement allowance shall be retroactive to August 20, 1951 and shall continue during her life. Such retirement allowance shall not be payable until the said Gertrude E. Durost has paid to the Maine retirement system the sum of \$851.36.

Chapter 166

RESOLVE, in Favor of a Retirement Allowance for Harriet McClaskey of South Portland.

Harriet McClaskey; retirement allowance. Resolved: That a retirement allowance of \$111.23 per month be, and hereby is, granted to Harriet McClaskey of South Portland, to be paid monthly from the funds of the Maine state retirement system. Such retirement allowance shall be retroactive to August 20, 1951 and shall continue during her life. Such retirement allowance shall not be payable until the said Harriet McClaskey has paid to the Maine retirement system the sum of \$680.76.

Chapter 167

RESOLVE, in Favor of a Retirement Allowance for Donald Mathieson of Freedom.

Donald Mathieson; retirement allowance. Resolved: That a retirement allowance of \$44.06 per month be, and hereby is, granted to Donald Mathieson of Freedom, to be paid monthly from the funds of the Maine state retirement system. Such retirement allowance shall be retroactive to August 20, 1951 and shall continue during his life. Such retirement allowance shall not be payable until the said Donald Mathieson has paid to the Maine retirement system the sum of \$487.
