## Chapter 186

### RESOLVE, in Favor of a Retirement Allowance for Doris D. Ladd of Hallowell.

Doris D. Ladd; retirement allowance. Resolved: That a retirement allowance of \$194.88 be, and hereby is, granted to Doris D. Ladd of Hallowell to be paid monthly from the funds of the Maine State Retirement System. Such retirement benefits shall be effective from July 20, 1952 and continue during her life. Such retirement allowance shall not be payable until the said Doris D. Ladd has paid to the Maine State Retirement System the sum of \$2,467.97 which has been refunded to Mrs. Ladd by the system.

## Chapter 187

### RESOLVE, Providing for a State Pension for Nancy A. Gilbert of Belfast.

Nancy A. Gilbert; state pension increased. Resolved: That Nancy A. Gilbert, of Belfast, be given credit for additional teaching time so that she may be entitled to a retirement benefit under the provisions of chapter 60 of the revised statutes.

That part of chapter 194 of the resolves of 1949 which provides for a state pension for Nancy Gilbert, of Belfast, is hereby repealed.

## Chapter 188

### RESOLVE, for Repairs of Church and Convent at Peter Dana Point and Old Schoolhouse Used for Religious Purposes at Princeton.

Church and convent at Peter Dana Point and Old Schoolhouse; appropriation for. Resolved: That there be, and hereby is, appropriated from the unappropriated surplus of the general fund of the state for the fiscal year ending June 30, 1954, to be expended for the purpose of repairing the church and teachers' house (convent) at Peter Dana Point and the old schoolhouse being used for religious purposes at Princeton, the sum of \$6,719. These funds shall be expended on authorization of the department of health and welfare; and be it further

RESOLVES, 1953

CHAP. 190

**Resolved:** That there be, and hereby is, appropriated from the unappropriated surplus of the general fund of the state the sum of \$5,000, to be expended for the purpose of repairing existing homes and building new homes for the Indians at the several reservations; these funds to be expended on authorization of the department of health and welfare.

## Chapter 189

**RESOLVE, Authorizing Forest Commissioner to Convey Certain Land in Hancock County.**

**Forest commissioner authorized to convey certain land. Resolved:** That the forest commissioner, in the name of the state of Maine be, and hereby is, authorized and directed to execute and convey by quit-claim deed for not less than \$800 to the highest bidder, all that part of the public lot that has not already been conveyed by the state of Maine, and known as the School Lot, situated in Plantation No. 33, M.D., that is located easterly of Great pond and the west branch of Union river which according to the Colby Atlas of Hancock county, 1881, is bounded and described as follows, to wit: On the north by lot No. 32; on the east by lot No. 35; on the south by lot No. 43 and lot No. 42 and on the west by the west branch of Union river and Great pond, containing approximately 50 acres.

## Chapter 190

**RESOLVE, Relating to Navigation on Part of Sebago Lake, Cumberland County.**

**Unlawful to anchor in part of Sebago lake. Resolved:** That the public utilities commission be, and hereby is, authorized and directed to cause the channel above and below White's bridge, so called, in Sebago lake, Cumberland county, to be buoyed 75 feet in width and it shall be unlawful to anchor in said channel 100 yards above and 200 yards below said bridge in the interest of safe navigation.
