## Chapter 27

### AN ACT to Incorporate Associated Industries of Maine.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Corporators.** John L. Baxter, Jr., Bernard F. Brady, Daniel E. Connelly, John F. Cooke, Henry W. Fales, Earl B. Foss, Lynwood S. Hatch, Harold H. Holden, Philip W. Hussey, Thomas G. Mangan, J. C. McCall, Millard S. Peabody, J. M. Pomeroy, Fred C. Scribner, Jr., J. William Schulze, Gerald L. Vaughan, Elmer L. Ward, Roy V. Weldon, J. Hollis Wyman, Wallace E. Parsons, Theodore F. Spear, Clarence L. Philbrick, and all persons who may hereafter become associated with them, are hereby created a corporation by the name of Associated Industries of Maine, for the purpose of improving the manufacturing conditions of the industries of Maine in the public interest; to inculcate just and equitable principles among its members, and between its members and their employees; to acquire, possess, and disseminate useful information for its members, and generally to promote the welfare of its members and their employees and the prosperity of the State of Maine and its industries; and by that name shall have power to sue and be sued, and possess all the rights and privileges of corporations under the laws of this state.

**Sec. 2. Officers; by-laws, etc.** Said corporation may elect such officers as it may deem necessary, and may adopt such constitution, by-laws, rules and regulations, not inconsistent with the laws of this state, as it may deem proper, for the management of its affairs, including the admission, government and expulsion of members.

**Sec. 3. First meeting.** The first meeting of the corporation may be called by any one of the persons named in this act, by mailing, postage prepaid, notice of the time and place of such meeting to each of the persons so named, at least one week prior to such meeting.

**Sec. 4. Recording certificate; fees.** Before commencing business the aforesaid corporation shall make and record a certificate of incorporation in accordance with section 4 of chapter 54 of the Revised Statutes of 1954, within the time limit therein expressed and pay the fees as required by said section 4.

## Chapter 28

### AN ACT Permitting Harold E. Erquhart of Lubec to Build Weir in Cobscook Bay, Washington County.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Weir or trap authorized.** Harold E. Erquhart, of Lubec in the county of Washington, is hereby authorized to build and maintain a weir or trap for fishing purposes in that part of the tidewaters of Cobscook Bay designated as Whiting Bay, in the Township of Edmunds in said county, to take, catch or kill all kinds of fish except Atlantic salmon.

**Sec. 2. Location and specifications.** The above-mentioned weir or trap shall be located as follows: The pound or bunt to be located on the first fourteen feet spot easterly of the dividing line between land of Irving Kelley and Robert Hallowell, both of said Edmunds, as indicated on United States Coast and Geodetic Survey Chart No. 801 from Calais to West Quoddy Head. Said pound or pocket to be 90 feet in diameter, with 2 wings or leaders therefrom, one extending in a general northerly direction not over 1,500 feet and the other extending in a general southerly direction not over 1,000 feet, together with a center fence extending westerly to the shore of said Whiting Bay and land of said Kelley and Hallowell.

**Sec. 3. Restrictions.** Said weir or trap shall not be built until permission has been granted to said Erquhart by the owners of said land to use the same; nor shall it be built or maintained so as to interfere with the rights of others or with navigation in any way.

## Chapter 29

### AN ACT Permitting Don H. Saunders of Lubec to Build Weir in Dennys Bay, Washington County.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Weir or trap authorized.** Don H. Saunders, of Lubec in the county of Washington, is hereby authorized to build and maintain a weir or trap for fishing purposes in the tidewaters of Dennys Bay, in the Township of Edmunds in said county, to take, catch or kill all kinds of fish except Atlantic salmon.

**Sec. 2. Location and specifications.** The above-mentioned weir or trap shall be located as follows: The pound or pocket or bunt to be located at approximately half way between the nine feet spot and the fourteen feet between Hallowell Island in said Edmunds and the mainland of said Edmunds, as indicated on United States Coast and Geodetic Survey Chart No. 801 from Calais to West Quoddy Head. Said pound or pocket or bunt to be 200 feet in diameter, with 2 wings or leaders therefrom, one extending in a general northerly direction 500 feet to said Hallowell Island and the other extending in a general southerly direction 500 feet to the shore of said Edmunds. The said Hallowell Island and the shore on the mainland in said Edmunds is owned by John Hallowell of Dennysville in said county of Washington.

**Sec. 3. Restrictions.** Said weir or trap shall not be built until permission has been granted to said Saunders by the owner of said land to use the same; nor shall it be built or maintained so as to interfere with the rights of others or with navigation in any way.
