PRIVATE AND SPECIAL, 1955

Chapter 80

AN ACT Relating to Power to Hold and Purchase Property by the City of Waterville.

Be it enacted by the People of the State of Maine, as follows:

- P. & S. L., 1887, c. 195, § 7, amended. Section 7 of chapter 195 of the private and special laws of 1887, as last amended by chapter 24 of the private and special laws of 1925, is hereby further amended to read as follows:
- 'Sec. 7. Limitation of power to purchase and hold property for municipal purposes increased to \$3,000,000. No money shall be paid out of the city treasury except on orders drawn and signed by the mayor, designating the fund or appropriation from which said orders shall be paid, nor unless the same shall be first granted or appropriated therefor by the City Council, and the City Council shall secure a prompt and just accountability by requiring bonds of sufficient penalty and surety or sureties, from all persons trusted with the receipt, custody or disbursement of money; the City Council shall have the care and superintendence of the city buildings and the custody and management of all city property, with power to let or sell what may be legally let or sold, and to purchase, take and hold, in the name of the city, real and personal property for municipal purposes to an amount not exceeding one million, five hundred thousand dollars \$3,000,000, and shall, as often as once a year, cause to be published for the information of the inhabitants, a particular account of receipts and expenditures, and a schedule of city property.'

Chapter 81

AN ACT Amending the Charter of the City of Brewer.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1931, c. 75, Art. II, § 2, amended. The 1st sentence of section 2 of article II of chapter 75 of the private and special laws of 1931 is hereby amended to read as follows:

'The city council shall consist of 5 members, who shall be elected at large by and from the qualified voters of the city for a term of 2 years from the 2nd Monday in January December next following the date of their election and until their successors are elected and qualified; except that at the first election after the adoption of this charter the three candidates having the largest number of votes shall serve for two years and the two candidates having the next largest number of votes shall serve for one year, and until their successors are elected and qualified.'

Sec. 2. P. & S. L., 1931, c. 75, Art. II, § 5, amended. The 1st sentence of section 5 of article II of chapter 75 of the private and special laws of 1931 is hereby amended to read as follows:

'The city council shall meet at the usual place for holding meetings at ten o'clock A.M. on the 2nd Monday in January December next following the regular city
