'Sec. 14. Salary of judge; expenses; rental; clerk hire. The judge of said court may demand and receive the same fees allowed to trial justices for like services, except that he may demand and receive for a complaint and warrant in criminal cases, \$1; for the entry of a civil action, 50c; and for the trial of an issue, civil or criminal, \$2 for the 1st day and \$1 for each day after the first occupied in such trial; to be paid to him by the plaintiff in civil cases, before trial, who shall recover the same as costs if he prevail in the suit; and the said judge shall receive as full compensation for his services, including the keeping of the records of said court, a salary of ~~\$1,300~~ \$1,500 a year, to be paid quarterly from the county of Penobscot; a condition preceding the payment of said salary as aforesaid, shall be the rendering by said judge of a correct and detailed statement to the county commissioners, and the payment over by said judge to the county treasurer, of all fees, both civil and criminal, collected by said municipal court for the preceding quarter or fractional part thereof. It shall be the duty of the county commissioners of the county of Penobscot to furnish and provide at the expense of said county, all books, blanks and all necessary stationery and supplies required for the use of the municipal court in the town of Dexter, in the transaction of the civil and criminal business of said court, including proper books for the record of all cases arising in said court, for which there shall be paid from the county of Penobscot, as rental, in quarterly payments, the sum of \$200 annually, and such additional amount for clerk hire as may be authorized by the county commissioners.'

## Chapter 87

AN ACT Increasing Salaries of the Judge and Recorder of the Millinocket Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1909, c. 393, § 15, amended. Section 15 of chapter 393 of the private and special laws of 1909, as last amended by chapter 160 of the private and special laws of 1951, is hereby further amended to read as follows:

'Sec. 15. Salaries of judge and recorder; clerk hire. The judge shall receive a salary, in full for all services, of ~~\$2,000~~ \$2,300 per annum to be paid him by the county of Penobscot, and the recorder a salary of ~~\$1,200~~ \$1,400 per annum, payable monthly, and such additional amount for clerk hire as may be authorized by the county commissioners.'

## Chapter 88

AN ACT Increasing Salaries of the Judge and Recorder of the Old Town Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1903, c. 153, § 9, amended. The last sentence of section 9 of chapter 153 of the private and special laws of 1903, as last amended by chapter 156

of the private and special laws of 1951, is hereby further amended to read as follows:

'The salary of the judge of said court shall be ~~\$2,000~~ \$2,300, annually; that of the recorder, ~~\$1,200~~ \$1,400, annually, and both of said salaries are to be paid monthly, and all other expenses of said court are to be paid quarterly from the treasury of the county of Penobscot, and such additional amount for clerk hire as may be authorized by the county commissioners.'

## Chapter 89

### AN ACT Increasing Salaries of the Judge and Recorder of the Bangor Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1895, c. 211, amended. The 1st sentence of the last paragraph of that part designated "Sec. 9" of chapter 89 of the private and special laws of 1953, which amended chapter 211 of the private and special laws of 1895, is hereby amended to read as follows:

'The salaries of the judge and recorder thereof, which are hereby fixed at ~~\$3,500~~ \$3,800 and ~~\$3,000~~ \$3,300, respectively, to be paid monthly, with all other expenses of said court, shall be paid from the treasury of the county of Penobscot.'

## Chapter 90

### AN ACT Increasing Salaries of the Judge and Recorder of Eastport Municipal Court.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. P. & S. L., 1915, c. 34, § 1, amended. The 1st sentence of section 1 of chapter 34 of the private and special laws of 1915, as last amended by chapter 55 of the private and special laws of 1953, is hereby further amended to read as follows:

'The judge of the Eastport municipal court shall receive as compensation an annual salary of ~~\$1,500~~ \$1,800, payable quarterly, from the county treasury of the county of Washington, on the 1st days of January, April, July and October.'

Sec. 2. P. & S. L., 1915, c. 34, § 2, amended. Section 2 of chapter 34 of the private and special laws of 1915, as last amended by chapter 65 of the private and special laws of 1947, is hereby further amended to read as follows:

'Sec. 2. Salary of recorder, when paid; fees. The recorder of the Eastport municipal court shall receive as compensation an annual salary of ~~\$200~~ \$250,
