Private and Special Laws

OF THE

STATE OF MAINE

As Passed by the Ninety-seventh Legislature

1955

of the private and special laws of 1951, is hereby further amended to read as follows:

'The salary of the judge of said court shall be ~~\$2,000~~ \$2,300, annually; that of the recorder, ~~\$1,200~~ \$1,400, annually, and both of said salaries are to be paid monthly, and all other expenses of said court are to be paid quarterly from the treasury of the county of Penobscot, and such additional amount for clerk hire as may be authorized by the county commissioners.'

Effective August 20, 1955

Chapter 89

AN ACT Increasing Salaries of the Judge and Recorder of the Bangor Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1895, c. 211, amended. The 1st sentence of the last paragraph of that part designated "Sec. 9" of chapter 89 of the private and special laws of 1953, which amended chapter 211 of the private and special laws of 1895, is hereby amended to read as follows:

'The salaries of the judge and recorder thereof, which are hereby fixed at ~~\$3,500~~ \$3,800 and ~~\$3,000~~ \$3,300, respectively, to be paid monthly, with all other expenses of said court, shall be paid from the treasury of the county of Penobscot.'

Chapter 90

AN ACT Increasing Salaries of the Judge and Recorder of Eastport Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1915, c. 34, § 1, amended. The 1st sentence of section 1 of chapter 34 of the private and special laws of 1915, as last amended by chapter 55 of the private and special laws of 1953, is hereby further amended to read as follows:

'The judge of the Eastport municipal court shall receive as compensation an annual salary of ~~\$1,500~~ \$1,800, payable quarterly, from the county treasury of the county of Washington, on the 1st days of January, April, July and October.'

Sec. 2. P. & S. L., 1915, c. 34, § 2, amended. Section 2 of chapter 34 of the private and special laws of 1915, as last amended by chapter 65 of the private and special laws of 1947, is hereby further amended to read as follows:

'Sec. 2. Salary of recorder, when paid; fees. The recorder of the Eastport municipal court shall receive as compensation an annual salary of ~~\$200~~ \$250,

payable quarterly, from the county treasury of the county of Washington, on the 1st days of January, April, July and October. All fees collected by him shall be paid over to the county treasurer.'

Sec. 3. **Effective date.** The provisions of this act shall be retroactive to January 1, 1955.

Chapter 91

AN ACT Relating to Rental for Brewer Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1949, c. 88, § 6, amended. Section 6 of chapter 88 of the private and special laws of 1949 is hereby amended to read as follows:

'Sec. 6. **Location of court; expense of court; rental.** Said court shall be held at such place as the city of Brewer shall provide and said city shall have power and it shall be its duty to raise money to provide a proper place for said court and its officers and suitably furnish, warm and light the said court room, for which there shall be paid from the county of Penobscot, as rental, the sum of \$200, annually, in quarterly payments. All other expenses of said court shall be paid from the treasury of the county of Penobscot.'

Chapter 92

AN ACT Relating to Salary of Judge of Brewer Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1949, c. 88, § 1, amended. The last sentence of section 1 of chapter 88 of the private and special laws of 1949 is hereby amended to read as follows:

'His salary shall be ~~\$1,500~~ \$1,800 per year, to be paid monthly from the treasury of the county of Penobscot.'

Chapter 93

AN ACT to Provide for the Creation of the Office of Director of Public Works for the City of Waterville.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1887, c. 195, § 10-A, additional. Chapter 195 of the private and special laws of 1887, as amended, is hereby further amended by adding thereto a new section, to be numbered 10-A, to read as follows:
