Chapter 113

AN ACT Relating to Certain Funds Held by Colby College as Trustee.

Be it enacted by the People of the State of Maine, as follows:

Certain funds held by Colby College as trustee may be returned. The President and Trustees of Colby College are hereby authorized, if they deem it expedient and proper, to transfer, convey and return to Coburn Classical Institute, Ricker College, formerly Ricker Classical Institute, Hebron Academy, Higgins Classical Institute and any other incorporated academies and schools for which they now hold property in trust, any and all property now held in trust by The President and Trustees of Colby College pursuant to Chapter 10 of the Private and Special Laws of 1887, or otherwise, for such institutions, academies and schools, the same when returned to any such institution, academy and school to be held and used for the purpose for which it was incorporated.

Chapter 114

AN ACT Increasing the Salary of the Judge of the Rumford Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1907, c. 429, § 1, amended. The 1st sentence of section 1 of chapter 429 of the private and special laws of 1907, as last amended by section 1 of chapter 150 of the private and special laws of 1951, is hereby further amended to read as follows:

'The judge of the Rumford Falls Municipal Court shall receive an annual salary of ~~\$2,400~~ \$3,500, payable ~~quarterly~~ monthly out of the county treasury of the county of Oxford, on the 1st ~~days~~ day of ~~July, October, January and April~~ each month, which shall be in full payment for his services as such judge.'

Chapter 115

AN ACT Increasing the Salary of the Judge of the Norway Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1907, c. 403, § 3, amended. Section 3 of chapter 403 of the private and special laws of 1907, as last amended by chapter 162 of the private and special laws of 1951, is hereby further amended to read as follows:

'Sec. 3. Salary of judge. From and after the 1st day of July, ~~1951~~ 1955, the judge of said municipal court shall receive an annual salary of ~~\$2,000~~ \$2,700, payable monthly out of the county treasury of Oxford county, on the 1st day of each month.'

Effective August 20, 1955
