Chapter 5

RESOLVE, Designating Fore River Bridge in Cumberland County as The Veterans Memorial Bridge.

Fore River Bridge designated The Veterans Memorial Bridge. Resolved: That the Fore River Bridge across Fore river between the cities of Portland and South Portland in Cumberland county be designated as The Veterans Memorial Bridge.

Effective August 20, 1955

Chapter 6

RESOLVE, Designating Part of U. S. Route No. 1 in Maine as Narraguagus Highway.

Part of U. S. Route No. 1 designated Narraguagus Highway. Resolved: That U. S. Route No. 1 between Milbridge and Cherryfield in Washington County be designated as Narraguagus Highway. Two suitable signs shall be erected at each end of said highway.

Chapter 7

RESOLVE, Regulating Fishing in Sawyer's Pond in Southport.

Emergency preamble. Whereas, acts and resolves do not become effective until 90 days after the legislature adjourns; and

Whereas, since Sawyer's Pond is the water reserve for the town of Southport, chemicals are to be used in the Spring of 1955 to treat such waters; and

Whereas, such chemical treatment will kill all fish in Sawyer's Pond; and

Whereas, the following legislation is vitally necessary to conserve the fish in the pond and prevent unnecessary spoilage; and

Whereas, in the judgment of the legislature, these facts create an emergency within the meaning of the constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Fishing in Sawyer's Pond; regulated. Resolved: That the Commissioner of Inland Fisheries and Game, be and hereby is directed to permit ice fishing in Sawyer's Pond, Southport, from the effective date of this resolve until the ice shall leave in the Spring of 1955.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.
