**Trescott Township, Washington County**

Lots 10, 11 and 12, R. 1; with buildings; Jones' plan, revised. Excepting Gaddis Brothers 40 acre parcel, described in deed book 501, page 381, Washington County Registry.

Sell to Daniel Tyler for \$595.17, and if he does not pay such amount within 60 days from effective date of this resolve, sell to highest bidder for not less than \$600.

**Trescott Township, Washington County**

Part Lot 21, S. R., W. Div., S. of Bog Brook; Jones' plan, revised.

Sell to highest bidder for not less than \$30.

**Trescott Township, Washington County**

Part Lot 5, S. R., W. Div., bounded N. by Cutler Road, E. by C. Ackley, S. by F. Moores; Jones' plan, revised.

Sell to Lewis Wilcox for \$29.32, and if he does not pay such amount within 60 days from effective date of this resolve, sell to highest bidder for not less than \$30.

**Chapter 15****RESOLVE, Changing the Name of Rattlesnake Pond to Pequawket Pond.**

Rattlesnake pond; name changed. Resolved: That the pond lying in the town of Brownfield, Oxford county, and being known as Rattlesnake Pond, be hereafter officially named and referred to as Pequawket Pond.

**Chapter 16****RESOLVE, Regulating Fishing in Rocky Lake and Sunken Lake in Washington County.**

Fishing in Rocky lake, regulated. Resolved: That the Commissioner of Inland Fisheries and Game, be and hereby is, authorized and directed to issue a rule and regulation opening Rocky Lake and Sunken Lake in Marion, Edmunds and Whiting, in the county of Washington, to ice fishing for all fish, from ice in to March 31 each year.
