## Chapter 31

### RESOLVE, Regulating Fishing in Square Pond, York County.

**Fishing in Square Pond; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation to remove all size and bag limits on white perch, pickerel and bass in Square Pond, in the towns of Acton and Shapleigh, York county. The open season to conform with the general law ice fishing and open water fishing seasons in all waters.

Effective August 20, 1955

## Chapter 32

### RESOLVE, Regulating Fishing in Goose Pond, York County.

**Fishing in Goose Pond; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation to remove all size and bag limits on white perch, pickerel and bass in Goose Pond in the town of Shapleigh, York County. The open season to conform with the general law ice fishing and open water fishing seasons in all waters.

## Chapter 33

### RESOLVE, Regulating Fishing in Little Ossipee Pond.

**Fishing in Little Ossipee Pond; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation removing all limits as to the size and number of perch, pickerel, bass and other warm water species of fish that may be taken from Little Ossipee Pond in the town of Waterboro, and county of York.

## Chapter 34

### RESOLVE, Regulating Fishing in Flagstaff Lake in Franklin and Somerset Counties.

**Fishing in Flagstaff Lake; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Flagstaff Lake in Franklin and Somerset Counties to ice fishing under the general law for Franklin County.
